


DESCRIPTION/JUSTIFICATION:

4-9015.00 – US 62 – Perform Low-Cost Safety Improvements on US 62 from MP 7.844 to MP 10.900 in Hardin County – Design - \$200,000; Right-of-Way – \$15,000; Utilities – \$100,000 – HSIP

HSIP – Low-Cost Safety Improvements are classified as a Grouped Projects in the TIP; therefore, a formal amendment is not required.

FISCAL CONSTRAINT: Funding for this improvement has been committed by the Kentucky Transportation Cabinet (KYTC); therefore, financial constraint of the TIP is maintained, as demonstrated in Table 11.
