

On May 5, 2020, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #28 to the FY 2017 – 2020 TIP and Modification #11 to the 2045 MTP.

### Administrative Modification #28:

The purpose is to update the project description of the "Various Continuing Programs" to align with the draft FY21 Unified Planning Work Program (UPWP). The "ITS & CMS Traffic Improvements" project has also been identified as a separate project and is no longer included in the Various Continuing Program project description. These minor adjustments to the project descriptions are to provide additional detail and clarity and do not affect the project cost or the fiscal balance of the TIP.
