

### **FY 2018-2022 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) ADMINISTRATION MODIFICATION #18**

#### **ACTION:**

The Radcliff/Elizabethtown Metropolitan Planning Organization (MPO) hereby modifies the FY 2018-2022 Transportation Improvement Program (TIP). This modification reflects the following:

#### **DESCRIPTION/JUSTIFICATION:**

The following TIP project (4-9012) is being modified to add the Right-of-Way and Utility phases:

**4-9012** – Mini Roundabouts at Various Intersections within the City of Elizabethtown – Right-of-Way - \$300,000 – Utilities - \$200,000 – HSIP

The following projects are being added to the TIP for the Construction phases for all seven (7) mini-roundabout locations in the City of Elizabethtown:

**4-9012.10** – Construct a Mini Roundabout at the Intersection of North Main St. & Crutcher St. – C - \$225,000 – HSIP

**4-9012.20** – Construct a Mini Roundabout at the Intersection of Dolphin Dr. & Josale Dr. – C - \$265,000 – HSIP

**4-9012.30** - Construct a Mini Roundabout at the Intersection of Commerce Dr. & Executive Dr. – C - \$350,000 – HSIP

**4-9012.40** – Construct a Mini Roundabout at the Intersection of North Main St. & Poplar St. – C - \$240,000 – HSIP

**4-9012.50** – Construct a Mini Roundabout at the Intersection of Woodland Dr. & Layman Ln. – C - \$240,000 – HSIP

**4-9012.60** – Construct a Mini Roundabout at the Intersection of Poplar St. & Sycamore St. – C - \$250,000 – HSIP

**4-9012.70** – Construct a Mini Roundabout at the Intersection of West Poplar St. & North Mantle Ave. – C - \$215,000 – HSIP

HSIP – Intersections are project types classified as a Grouped Projects in the TIP; therefore, a formal amendment is not required.

FISCAL CONSTRAINT: Funding for this improvement has been committed by the Kentucky Transportation Cabinet (KYTC); therefore, financial constraint of the TIP is maintained, as demonstrated in Table 11.
