SUBJECT: Notification of Administrative Modification #6 to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #25 to the 2045 Metropolitan Transportation Plan (MTP)

On July 30, 2021, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #6 to the FY 2021 – 2024 TIP and Modification #25 to the 2045 MTP.

Administrative Modification #6:

This action updates the previously published documents and tables. This modification is considered a Grouped Project* (Highway Safety Improvement Program) which does not impact the financial constraint of the TIP. The modification adds the following safety project in Jessamine County:

- Perform low cost safety improvements on KY 169 from MP 11.978 to MP 16.555
 - o \$2,385,000 (Federal HSIP funds) + \$265,000 State Match = \$2,650,000 total
