Birds and Kentucky Airports



Kentucky airports reported 1,038 wildlife strikes over the last 5 years. Of these, only 19 strikes were reported to have caused damage totaling \$341,370 dollars. Over 99% of these strikes involved birds and at least 47 different species of birds were identified by their remains.

While none of these strikes resulted in human fatalities, the potential for catastrophe is easy to understand in light of recent wildlife strikes. The best known is US Airways Flight 1549 in which a passenger plane landed on the Hudson River after ingesting three Canada geese through the engines shortly after takeoff. Clearly, wildlife strikes have the potential for devastating losses and all wildlife conflicts should be taken seriously.

All airports should take three basic steps to minimize wildlife conflicts: assess hazards, make a management plan, and implement it. The goal is to reduce the number and severity of strikes.

Problem Identification

First, airports should evaluate and identify any potential wildlife conflicts on the airport and adjacent properties. This process, called a wildlife hazard assessment, can be either informal, taking only a couple of hours, or a year-long formal process. A basic assessment involves identifying wildlife species on or near the airport runways and what is attracting wildlife to these areas.

All wildlife species are evaluated during an assessment, but large mammals and certain groups of birds receive the most consideration due to the higher damage costs and likelihood of catastrophic collisions with these species. These groups include:

Waterfowl – including geese, ducks and gulls. Typically large to medium birds, waterfowl usually fly in flocks. Sometimes an individual bird can cause significant damage to aircraft, but their flocking behavior usually results in multiple collisions when strikes occur.

Large wading birds – including herons and cranes. Depending upon the season, both can be found either individually or in flocks. These slow-flying birds have difficulty avoiding fast-moving and relatively quiet aircraft.

Raptors – including hawks, owls, vultures and eagles. Airports provide these birds with easy hunting of rodents and other prey in the grassy expanses surrounding runways. Most raptors are large enough to cause significant damage even if a single bird collides with an aircraft.

Small to medium-sized flocking birds – including crows, blackbirds, starlings, doves and pigeons. While an individual bird of these species would likely not cause significant problems in a collision, their flocking behavior means that one-bird strikes are rare.



Wildlife Hazard Management Plan

The second step in minimizing airport-wildlife conflicts is exploring options to reduce the attractiveness of the specific airport and surrounding landscape to the species identified in the assessment. Feasible and potentially successful options to reduce wildlife hazards can be incorporated into an airport-specific plan, which describes the techniques and their implementation.

Management plans do not need to be elaborate or exhaustive but they should follow an integrated wildlife damage management approach. Namely, they should utilize all possible techniques at times and in situations where each technique is most effective and efficient at minimizing potential conflict.

A good plan manages both the environment and wildlife, and considers all possible mitigation techniques including:

Exclusion – Exclusion means any physical barrier installed to block access by wildlife to a particular area. The most common airport exclusion is a perimeter fence. Designed to keep people and large animals off of runways, a perimeter fence can be modified and maintained to exclude much smaller mammals and sometimes birds. Mesh netting or Nixalite™ can protect hangers from nesting and roosting birds, thereby reducing the number of pigeons, doves, or starlings in the area. Large plastic balls or grid wires installed over retaining ponds will keep many waterfowl from using these bodies of water.

Vegetation Management – Sometimes grass type and height attract certain species of birds and rodents. By altering these two characteristics, the airfield's attractiveness can be greatly reduced.

Habitat Management – Often unused properties on and adjacent to airport lands are overgrown with trees and shrubs. Simply clearing these areas can keep many birds and mammals from using them for nesting sites or cover from predators.

Cultural Alterations – Airports frequently use adjacent property as green spaces, parks, or leased cropland. Eliminating recreational feeding of geese at such parks reduces the likelihood that geese will be found in large populations nearby. Wildlife sanctuaries near airports can be managed to minimize certain species' populations. Limiting the type of crops that farmers grow on leased lands can reduce attractiveness to wildlife. On occasion, airport employees consider airport lands to be private hunting preserves; eliminating hunting activities on these properties reduces management for wildlife and can keep populations from becoming a problem.

Population Management – For example, reproduction of Canada geese can be significantly reduced by oiling or addling eggs, which requires registration with the U.S. Fish and Wildlife Service.

Dispersal – Harassment can disperse wildlife using noisemakers like fireworks, loud distress calls, or propane cannons. Some repellents, like methyl anthranilate, can work as a harassment tool. Scare-eye balloons, Mylar tape, and flagging also works in limited situations.

Population Reduction – In some instances, none of the described techniques work effectively to reduce particular wildlife hazards. In these cases, removal of the individual animal may become necessary through trapping, shooting and/or use of immobilization drugs. Wildlife Hazard Management Plans should consider the environmental consequences of all techniques.

Implementing a Wildlife Hazard Management Program

The third step in minimizing wildlife conflicts is actual implementation of your plan. Many techniques listed above can be utilized by airport personnel or other contracted personnel. Most exclusions and alterations to vegetation, habitat, and culture typically can be done without permits provided that no wildlife will be injured or killed by the specific action. However, Federal law protects all migratory birds. While harassment of most birds is legal, the actual lethal take or live handling is not allowed, unless the airport or individual contractor hold permits from the U.S. Fish and Wildlife Service.

Where to Start

Airport managers can start by contacting wildlife professionals who specialize in dealing with airports. Several private sector companies provide these services and can be found on the internet. The FAA and NASAO have signed memoranda of understanding with USDA's Wildlife Services (WS), the Federal agency that can assist managers throughout this process. WS has a network of trained and certified biologists throughout Kentucky who can provide airport site visits and wildlife consultations, develop wildlife hazard assessments and wildlife hazard management plans, and conduct operational management programs.

When appropriate, WS personnel work with the US Fish and Wildlife Service to evaluate wildlife control needs and initiate the depredation permit process. They are also certified to train airport personnel to recognize hazardous wildlife conditions and implement appropriate actions.

WS can provide assistance with many issues over the phone, but depending upon resources, personnel can also conduct site visits of the airport at no charge. Each time WS responds to a request for assistance, personnel will evaluate potential wildlife conflicts and provide guidance on the best techniques to resolve those conflicts. This includes:

- Outlining what actions airport personnel can take to resolve their own wildlife conflicts;

- Demonstrating how to implement any techniques that WS recommends;

- Outlining what actions can be taken by a private sector wildlife control operator; and

- Outlining what actions can be taken by USDA Wildlife Services.




