#### **Question and Answer**

Q: Emanuel Gialousis from G-Force Contracting asked if the state would entertain the contractor using black beauty as their blast media due to the location and the limited access to the bridge.

A: Mike Baase stated that KYTC will always entertain anything that is submitted but the contact as presented at this time is to do it as a recycle job. Tom Mathews from KYTC stated that they would review the weight limits on the structures leading to this bridge and if anything changes there will be an addendum issued.

The blast media shall be recyclable steel grit.

Q: Dean Croft from KYTC asked if there are any changes to the repairs on this bridge do they have to get the historical society to approve them.

A: Tom Mathews stated yes.

Q: Mike Baase from KYTC stated that this bridge currently has a posting of a 3 ton weight limit and asked if when the contractor started to remove gussets and vertical members, does the bridge need to be shut down.

A: There was a discussion concerning this question and Tom Mathews stated that he would check into it and if anything changes there would be an addendum posted. See addendum 1 for this contract CID No.112958

### 06-30-2011 Pre-Bid Field Review Questions

- Q. Will existing structure plans be made available to the contractor?
- A. Yes, the existing structure plans will be posted under the "project related information" link on the Cabinet's web site.
- Q. Can the structures on KY 490 that will have to be crossed handle the load of equipment that may be used by the contractor?
- A. Any equipment exceeding 32 tons shall be mobilized and staged from the northwest end of the structure on KY 490.
- Q. Can the Contactor use silicon in place of neoprene for the joint sealing at the southeast end of the structure?
- A. Yes, the Contactor shall be permitted to use silicon in accordance with the standard Specification.
- Q. Will night time work be permitted?
- A. Night time will be permitted as long as no complaints from residents in the surrounding area are received.
- Q. Will the Contractor be permitted to stage equipment on KY 89 at the north-west end of the bridge?
- A. Yes, Contactor shall be permitted to stage from KY 89. The Contractor shall arrange the lane closure signage as applicable.
