SPECIAL NOTE FOR LIQUIDATED DAMAGES

In addition to the Liquidated Damages specified in Section 108.09, Liquidated Damages in the amount of \$5,000.00 per day will be assessed for each day or part of a day a lane closure remains in place after the completion date of May 24th, 2012.

Traffic may be diverted into the opposite tunnel bore no more than 63 calendar days to complete repairs in the respective tunnel. Both directions of traffic will be in a single tunnel bore no more than 126 days total on this project. If either the 63 days or 126 days are exceeded a disincentive in the amount of \$5,000 per day will be assessed.

Any lane closure during a restricted time will result in a disincentive of \$5,000 per day prorated to the nearest hour.

Contrary to Section 108.09, Liquidated Damages will be assessed regardless of whether seasonal limitations prohibit the Contractor from performing work on the controlling item.

Except as provided herein, all other applicable provisions of Section 108.09 shall apply.
