CAP Description

THE RUSSELL FORK OF THE BIG SANDY RIVER IS A TOURIST DESTINATION IN THE MONTHS OF MAY AND OCTOBER. THERE IS A RAFTING CLININC HELD EACH MAY AT CARSON ISLAND, WHICH IS APPROXIMATELY ONE HALF MILE UPSTREAM FROM THE PROJECT AREA. DURING THE MONTH OF OCTOBER, THERE ARE CONTROLLED RELEASES FROM THE JOHN FLANAGAN DAM AND MANY RAFTERS AND KAYAKERS USE THE RIVER.

IF THE CONTRACTOR DECIDES TO CONSTRUCT A LOW WATER BRIDGE, HE SHOULD MAINTAIN 10'-12' CLEARANCE ABOVE THE LOW FLOW OF THE RIVER. THE RIVER RISES APPROXIMATELY 2' DURING THESE CONTROLLED RELEASES.

THE CONTRACTOR SHALL INSURE THE RAFTERS AND KAYAKERS TRAVERSING THE RIVER THROUGH THE PROJECT AREA ADEQUATE PROTECTION FROM CONSTRUCTION ACTIVITIES. THIS MAY INVOLVE PLACING SIGNS AT VARIOUS LOCATIONS UPSTREAM TO MAKE THE KAYAKERS AND RAFTERS AWARE OF THE CONSTRUCTION PROJECT. A SUGGESTION WOULD BE RATLIFF HOLE. RATLIFF HOLE IS LOCATED ADJACENT TO THE RUSSELL FORK AND CAN BE ACCESSED VIA KY 80 APPROXIMATELY 2 MILES UPSTREAM FROM THE PROJECT. THE PROPERTY IS OWNED BY THE BREAKS INTERSTATE PARK.

THE CONTRACTOR SHALL PRESENT A PLAN TO THE RESIDENT FOR APPROVAL.

CONTRACTOR SHOULD CONTACT STEVE RUTH AT 606-205-3157 (CELL) OR 606-754-4349 TO DISCUSS IN FURTHER DETAIL THE RAFTING ACTIVITIES THAT TAKE PLACE ON THE RIVER.

WHILE MAY AND OCTOBER ARE THE PEAK MONTHS OF KAYAKING AND RAFTING ACTIVITY, THERE ARE SOME WHO KAYAK YEAR ROUND.

THERE WILL BE NO PAYMENT FOR THIS WORK.
