SPECIAL NOTE FOR FEMA APPROVAL

The Contractor shall not be allowed to conduct any construction activities, other than clearing and grubbing, on the mainline from the US 79 intersection to station 220+00 until the Department has received approval from FEMA for the construction activities that will be occurring in the FEMA regulated floodway that exists in this area. The FEMA approval is anticipated to be received by June 1, 2016. If FEMA approval is not received by June 1, 2016, the fixed completion date for this project will be adjusted by the number of days beyond June 1st that it takes to obtain the necessary approval.

CAP Description

AS PER AGREED ORDER OF SETTLEMENT, THE DEPARTMENT HAS AGREED TO PAY FOR EXTENSION OF A 1-1/2INCH PRIVATE WATERLINE TO THE WEST (RIGHT) SIDE OF THE BYPASS. THE PROPERTY OWNER'S CONTRACTOR WILL INSTALL THE WATER LINE ONCE THE HIGHWAY CONTRACTOR HAS INSTALLED THE STEEL ENCASEMENT. ONCE THE ENCASEMENT IS INSTALLED AND THE WATER LINE CONSTRUCTED BY OTHERS. THE PROPERTY OWNER IS TO RELOCATE CATTLE OPERATION TO THE WEST (RIGHT) SIDE OF THE BYPASS. THE HIGHWAY CONTRACTOR SHALL COORDINATE WITH THE PROPERTY OWNER TO GIVE APPROPRIATE NOTICE SO THAT THE PROPERTY OWNER'S CONTRACTOR CAN MOBILIZE AND CONSTRUCT THE WATER LINE. THE HIGHWAY CONTRACTOR SHALL NOT IMPEDE THE ABILITY OF THE PROPERTY OWNER TO HAVE UNINTERRUPTED ACCESS TO WATER FOR ITS CATTLE OPERATION.

CAP Description

AS PER AGREED ORDER OF SETTLEMENT, THE HIGHWAY CONTRACTOR SHALL ENSURE CONTINUOUS ACCESS TO BOTH SIDES OF THE CONSTRUCTION AREA AFTER INSTALLATION OF FENCING ON THE ROBEY PROPERTY VIA GATE(S). THE HIGHWAY CONTRACTOR SHALL PROVIDE A GRAVEL ACCESS POINT AT THE LOCATION OF THE GATE(S) ACROSS THE CONSTRUCTION SITE AT ALL TIMES DURING CONSTRUCTION.
