CAP #1

Martin County Water and Sewer District have an active 10 inch sewer main on the project. Contractor shall use extreme care when removing any material from near this line. Contractor should refrain from taking heavy equipment over this line when possible. No parking of heavy equipment shall be allowed directly over line. Contractor will be responsible for any damage to the line done during construction. Contact John Mills @ 606-298-7439.

CAP #2

Martin County Water and Sewer District have an active 6 inch water main on the project. Contractor shall use extreme care when working near this line. Contractor should refrain from taking heavy equipment over this line when possible. No parking of heavy equipment shall be allowed directly over line. Contractor will be responsible for any damage to the line done during construction. Contact John Mills @ 606-298-7439.

CAP #3

Per an MOA between KYTC and Martin County dated 4/28/13, KYTC accepted responsibility to design and construct this bridge as part of a future KY 40-KY 3 connector. The completion of this roadway and all future maintenance for this connector is the responsibility of Martin County. Any associated property transfers relating to the public right of way for this connector will be finalized at a later date. The contractor is informed that the affected property owners have granted rights to KYTC to conduct the operations necessary to complete the work included with the bridge project.

CAP #4

The contractor is advised that the construction of the remaining portions of the KY 40-KY 3 connector may proceed concurrent with the KYTC construction project. The contractor should contact the appropriate entities (Martin County, R&J Development, and/or others) to coordinate their activities.

CAP #5

KYTC will bind and require the Project contractor(s) to defend, hold harmless and indemnify R & J Development, LLC from and against any and all claims, losses, liabilities, penalties, fines, costs, and expenses arising solely out of or directly from any use of the R & J Development, LLC, properties by the Project contractor(s). Provided, however, that the Project contractor(s) shall not incur or be held liable for, and shall not be obligated to defend, hold harmless and indemnify R & J Development, LLC, with respect to any such claims, losses, liabilities, penalties, fines, costs, and expenses that arise solely out of or directly from the activities of R & J Development LLC.
