The Kentucky Transportation Cabinet has scheduled a Public Information Meeting for the proposed reconstruction of KY 7 in Elliott and Morgan Counties. The proposed project begins at the South City Limits of Sandy Hook in Elliott County and extends south to KY 711 in Wrigley, Morgan County. The purpose of the meeting is to present the preliminary alternates currently under study. Those attending will be encouraged to provide feedback regarding the alternatives. Anyone having an interest in this project is urged to attend this meeting.

The public meeting will run from 5:00 PM to 7:00 PM. Transportation Cabinet representatives will be available to receive comments and respond to questions. The meeting will be conducted in an open format, meaning that interested parties may attend at any point in the meeting's duration.

Both written and oral statements will be accepted at the meeting. A recording device will be made available for those who desire to make oral statements, and a comment sheet will be distributed to make it more convenient to provide written comments.

Written statements will be accepted at the meeting and for a period of 15 days after the Public Information Meeting. Written statements should be addressed to Darrin Eldridge, P.E., Kentucky Department of Highways, District 9 Office, P.O. Box 347, Flemingsburg, KY 41041, or returned using the postage-paid envelope provided with the comment sheet. All recorded and written statements will become part of the official record. Once compiled, the meeting record will be made available for review and copying after an Open Records Request has been received and approved. All Open Records Requests must be submitted to the Office of Legal Services, Kentucky Transportation Cabinet, 200 Mero Street, Transportation Office Building, Frankfort, Kentucky 40622.
