The Kentucky Transportation Cabinet, Department of Highways, has scheduled a Public Information Meeting on the above referenced project to be held Thursday, June 5, 2014, 5:00 PM to 7:00 PM at the Tilden Hogge Elementary School gymnasium located at 5955 Cranston Road, Morehead, Kentucky 40351. This project is the reconstruction of KY 377 (Cranston Road) from the intersection of KY 32 to milepoint 8.25. This meeting has been scheduled to give all interested persons an opportunity to become better informed and to express their views concerning the proposed project. Persons interested or affected by the proposed improvement are encouraged to attend.

The Public Information Meeting will be an “Open House” format with no formal presentation. Representatives from the Kentucky Transportation Cabinet (KYTC) and their consultants will be available to answer questions. Plans and exhibits will be displayed at the meeting. This is an informal type of meeting in which interested persons may come at anytime between the hours of 5:00 PM to 7:00 PM to review the plans, discuss the project, and express their views concerning the social, economic, historic and environmental effects the proposed project will have upon individuals, businesses, cultural resources and other organizations in the area and community. A handout, containing project information, will be distributed at the meeting. In addition, information concerning Section 106 of the National Historic Preservation Act will be available for anyone interested in signing up for this important process.

Oral and written statements will be accepted during the meeting. Written statements will be accepted, and information made available, for a period of fifteen (15) days after the meeting at the address listed below. Once compiled, the meeting record will be made available for review and copying only after an Open Records Request has been received and approved. All Open Records Requests must be submitted to the Kentucky Transportation Cabinet, Office of Legal Services, 200 Mero Street, Frankfort, Kentucky 40622.
