RAIL VOLUME UP!

Rail volume in the United States is up 4.1 percent from this time last year, with a grand total of 33 Billion ton-miles. Railroad Weekly also reported that U.S. intermodal rail traffic was up 8.6 percent. Rail traffic was up in Canada as well, Canadian carload rail traffic was up 4.4 percent, and Canadian intermodal rail traffic was up 10.3 percent. However, rail traffic in Mexico did not fare as well, Mexico's Kansas City Southern de Mexico's carload rail traffic was down 14.5 percent.

DATA AVAILABLE FROM LARGE TRUCK CRASH CAUSATION STUDY

The U.S. Federal Motor Carrier Safety Administration (FMCSA) has just made public the database from their Truck Crash Causation Study. FMCSA's is conducting their own analysis as well as sponsoring non-governmental organizations that are interested in analyzing the study results. SHORTAGE OF LONG-TERM TRUCK PARKING

The new transportation bill, Safe, Accountable, Flexible, Efficient, and Transportation Equity Act: A Legacy for Users (SAFETEA-LU), Section1305, directed the Secretary of Transportation to establish a pilot program to address the long-term parking shortages along the National Highway System (NHS).

It has been determined that \$5.384 million is available for grants in FY 2006 under Section1305, after obligation limitations. Grants may be funded at an 80-100% funding level. Applications must be submitted through the Kentucky Transportation Cabinet, via the Kentucky FHWA Division Office, to the Federal Highway Administration (FHWA) Office of Freight Management and Operations. The Kentucky Transportation Cabinet will administer awarded projects as Federal aid grants. The Water Resources Development Act or WRDA has received both House and Senate approval. This legislation includes funding for ecosystem restoration and seven new 1,200-foot locks. The bill still requires

PUBLICATIONS

Two recent freight-related reports developed as part of the FHWA's Strategic Multimodal Analysis (SMA) Study have just been released.



Coordinated by the FHWA's Office of Transportation Policy Studies, the study's objective was to develop the capability for analyzing multimodal policy options that address critical national freight transportation issues. The SMA project will improve the understanding of the impacts of freight bottlenecks to Interstate commerce and will develop a framework for estimating the impacts of improvements to the nation's multimodal transportation system, with a focus on highway, rail, and water options for freight movement. The SMA project is composed of five tasks: (1) Initial Assessment of Nationwide Freight Bottlenecks; (2) Impact Model Development; (3) Infrastructure and Freight Report on Chicago - New York Corridor; (4) Scenario Development and Testing; and (5) Final Report. The following is a synopsis of two recent reports developed via the SMA Study:

1. Chicago-New York City Corridor Analysis Report: This report summarizes the testing of the SMA modeling framework on a sample corridor encompassing large freight activity for all the land transportation modes (truck, rail, and water). Covering the Chicago to New York City corridor, this report describes the current freight transportation network for highways, rail, and waterways, current and forecasted freight traffic, as well as potential corridor improvements for meeting future freight transportation requirements with a particular focus on highway freight bottlenecks. While this particular

effort and report focus on the seven States within this travel corridor, it demonstrates the capabilities of using freight analysis tools for corridor-level analysis. This report is available at: http://199.79.179.101/policy/otps/sma/index.htm.

2. An Initial Assessment of Freight Bottlenecks on Highways: This white paper is an initial effort to identify and quantify, on a national basis, highway bottlenecks that delay trucks and increase costs to businesses and consumers. Specifically, this paper is a "first look" at the impacts and costs of highway bottlenecks on truck freight shipments, with a focus on bottlenecks that cause recurring congestion. As outlined in this report, a truck bottleneck is defined by a combination of three features: the type of constraint, the type of roadway, and the type of freight route. COMMENTS REQUESTED BY FHWA

In accordance with the SAFETEA-LU requirement that the Secretary of Transportation establish regulations on the Projects of National and Regional Significance (PNRS) Program, the Federal Highway Administration's Office of Freight Management and Operations published a Notice of Proposed Rule Making (NPRM) for the PNRS Program in the July 24th Federal Register. The PNRS program has the potential to improve freight mobility and advance the goals of the Secretary's Congestion Initiative. The NPRM addresses eligibility, selection and rating criteria for PNRS project proposals - we are seeking your input on these criteria. In addition to comments on these criteria, FHWA is looking to this NPRM to provide specific comments that contribute to an understanding and a quantification of the term national and/or regional economic benefits, and the nature and form of full funding grant The comment period for this proposed rule making will close on agreements. 22nd.
