- KY 1105, from the intersection of North Sixth Street and US 60 (Broadway) in Barlow, via North Sixth Street in Barlow and via Oscar, to the junction with KY 473 in Bandana, a distance of 11.675 miles. (MP 0.000 to MP 11.675)
- KY 1290, from the intersection of Sixth Street and KY 121 (Court Street) in Wickliffe via Sixth Street in Wickliffe and via Slater to the junction with KY 802, a distance of 9.104 miles. (MP 0.000 to MP 9.104)
- KY 1345, from the westernmost junction with KY 286 to the junction with KY 1290 at Slater, a distance of 3.226 miles. (MP 0.000 to MP 3.226)
- KY 1367, from the junction with US 62 in Lovelaceville to the junction with KY 286, a distance of 3.219 miles. (MP 0.000 to MP 3.219)
- KY 1782, from the junction with KY 473 near Needmore to the intersection with KY 358, a distance of 0.909 mile. (MP 0.000 to MP 0.909)
- KY 1837, from the junction with KY 802 in Blandville to the junction with US 62 in Lovelaceville. Also, from another junction with US 62 in Lovelaceville to the McCracken County Line, a distance of 8.635 miles. (MP 0.000 to MP 8.191)(MP 8.191 to MP 8.635) ***(Note: Includes the 0.050 mile one-way couplet westbound in Blandville from MP 0.060 to MP 0.110)***

KY 2532, from the junction with KY 286 northeast of Gage, via County Line Road and via Ceredo, to the McCracken County Line, a distance of 5.268 miles. (MP 0.000 to MP 5.268)
