CLAY COUNTY STATE PRIMARY ROAD SYSTEM

The routes as designated hereinafter were established by OFFICIAL ORDER # 85885 on March 19, 1981 and OFFICIAL ORDER # 86977 on August 12, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.
