## ESTILL COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state maintained system by classification in Estill County is current as of <u>August 17, 2021</u>. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86758 on May 19, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

## STATE PRIMARY SYSTEM

KY 52, from the Madison County Line to the intersection with KY 1571 near Ravenna, a distance of 9.480 miles. (MP 0.000 to MP 9.480)

### STATE SECONDARY SYSTEM

KY 52, from the intersection with KY 1571 near Ravenna to the Lee County Line, a distance of 11.560 miles. (MP 9.480 to MP 21.040)

KY 82, from the junction with KY 89 at Hargett to the Powell County Line, a distance of 5.029 miles. (MP 0.000 to MP 5.029)

KY 89, from the Jackson County Line to the junction with KY 52 in Irvine. Also, from another junction with KY 52 in Irvine, via Main Street, and via Hargett and Palmer, to the Clark County Line, a distance of 22.428miles. (MP 0.000 to MP 11.372)(MP 11.372 to MP 22.428)

KY 213, from the junction with KY 52 at Pitts to the intersection at Crowe Hollow Road, a distance of 2.088 miles. (MP 0.000 to MP 2.088)

KY 499, from the intersection with KY 594 (north), via Wisemantown to the junction with KY 52. Also, from another junction with KY 52, via the Joseph Proctor Memorial Bypass to the junction with KY 89, a distance of 4.089 miles. (MP 5.126 to MP 7.741)(MP 7.741 to MP 9.215)

KY 1571, from a junction with KY 52 (Third Street) in Ravenna via Millers Creek, to another junction with KY 52 west of Crystal, a distance of 5.580 miles. (MP 0.000 to MP 5.580)

#### **RURAL SECONDARY SYSTEM**

KY 213, from the intersection at Crowe Hollow Road to the Powell County Line, a distance of 3.995 miles. (MP 2.088 to MP 6.083)

KY 499, from the Madison County Line, via Witt to the intersection with KY 594 (north), a distance of 5.126 miles. (MP 0.000 to MP 5.126)

KY 594, from the Madison County Line, via Jinks, to the junction with KY 499. Also, from another junction with KY 499 near Witt to the junction with KY 52, a distance of 16.068 miles. (MP 0.000 to MP 13.091)(MP 13.091 to MP 16.068)

KY 794, from the junction with KY 1705 north of North Irvine to the junction with KY 89 south of Hargett, a distance of 3.226 miles. (MP 0.000 to MP 3.226)

KY 851, from the Lee County Line, via Leighton, to the junction with KY 89 in South Irvine, a distance of 11.594 miles. (MP 0.000 to MP 11.594)

KY 1057, from the junction with KY 213 at Furnace, extending eastward to the Powell County Line, a distance of 0.318 mile. (MP 0.000 to MP 0.318)

KY 1139, from a point south of Round Mountain Road to the junction with KY 594, a distance of 2.768 miles. (MP 0.000 to MP 2.768)

KY 1209, from the Lee County Line to a point on the Jackson County Line. Also, from the Jackson County Line to the junction with KY 89 near Wagersville, a distance of 8.311 miles. (MP 0.000 to MP 0.396)(MP 0.396 to MP 8.311)

KY 1353, from the junction with KY 52, east of the Madison County Line, to another junction with KY 52, a distance of 2.813 miles. (MP 0.000 to MP 2.813)

KY 1457, from the junction with KY 52 near West Irvine, via Witt Springs, to Witt Cemetery Road, a distance of 5.706 miles. (MP 0.000 to MP 5.706)

KY 1705, from the junction with KY 89 to the end of state maintenance, a distance of 2.666 miles. (MP 0.000 to MP 2.666)

KY 1886, from the junction with Nolan Creek Road to the junction with KY 89, a distance of 4.985 miles. (MP 0.000 to MP 4.985)

KY 2001, from the junction with KY 82 to the Powell County Line, a distance of 0.693 mile. (MP 0.000 to MP 0.693)

KY 3325, from the junction with KY 52 near the Madison County Line via Winston to another junction with KY 52. Also, from a junction with KY 1353 to the junction with KY 1457, a distance of 3.850 miles. (MP 0.000 to MP 1.613)(MP 1.613 to MP 3.850)

KY 3327, from the junction with KY 594 near Witt, via Stacy Lane Road to the junction with KY 52, a distance of 2.267 miles. (MP 0.000 to MP 2.267)

KY 3328, from the junction with KY 594, to the junction with KY 499 at Wisemantown, a distance of 1.254 miles. (MP 0.000 to MP 1.254)

KY 3547, from the junction with KY 52 to junction with KY 499, a distance of 2.823 miles. (MP 0.000 to MP 2.823)

### SUPPLEMENTAL ROADS

KY 975, from the junction with KY 1182 to the end of state maintenance near Fitchburg, a distance of 3.448 miles. (MP 0.000 to MP 3.448)

KY 1182, from the junction with KY 52, via Cobhill Road and Patsy Road to the end of state maintenance at a point east of the Watson Ridge Road, a distance of 3.700 miles. (MP 0.000 to MP 3.700)

KY 1645, from the junction with KY 2461 (Broadway Street), in Irvine to the junction with KY 1571, a distance of 2.238 miles. (MP 0.000 to MP 2.238)

KY 1840, from the beginning of state maintenance to the junction with KY 89, a distance of 0.545 mile. (MP 0.000 to MP 0.545)

KY 1886, from the intersection with KY 89 to the junction with Racetrack Road at Iron Mound, a distance of 1.358 miles. (MP 4.985 to MP 6.343)

KY 2454, from the junction with KY 89 (Main Street) in Irvine, via Orchard Avenue and Park Avenue, to the junction with KY 2459, a distance of 0.166 mile. (MP 0.000 to MP 0.166)

KY 2455, from the junction with KY 89 (Main Street) in Irvine, via Rice Street, to a point at the end of state maintenance, a distance of 0.217 mile. (MP 0.000 to MP 0.217)

KY 2459, from a point at the beginning of state maintenance on Carhartt Avenue in Irvine, via Carhartt Avenue, to the junction with KY 89, a distance of 0.373 mile. (MP 0.000 to MP 0.373)

KY 2460, from the junction with KY 52 in Irvine, via Court Street to the junction with River Drive, a distance of 0.379 mile. (MP 0.000 to MP 0.379)

KY 2461, from the junction with KY 89 via Broadway Street and Eighth Street in Ravenna, to the junction with KY 52 in Ravenna, a distance of 1.572 miles. (MP 0.000 to MP 1.572)

KY 3326, from the barricade at the cul-de-sac south of KY 499 (Irvine Bypass) extending south to a junction with KY 52, a distance of 0.870 mile. (MP 0.000 to MP 0.870)

KY 3329, from the junction with KY 851, via Old Landing Road to the end of state maintenance, a distance of 2.000 miles. (MP 0.000 to MP 2.000)
