STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Greenup County is current as of February 09, 2023. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85710 on November 20, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 23, from the Boyd County Line, via Russell, Raceland, Wurtland, Greenup, and South Shore to the south end of the U.S. Grant Bridge, a distance of 28.760 miles. (MP 0.000 to MP 28.760)***NOTE the U.S. Grant Bridge, 0.248 mile is owned and maintained by the State of Ohio.

KY 8, from the intersection with KY 8S (Spur) to the junction with US 23 at the south limits of the U.S. Grant Bridge, a distance of 1.023 miles. (MP 2.000 to MP 3.023)

KY 8S (Spur), from the junction with KY 8 at a point west of US 23, extending northward, via approach roadbed and bridge structure to the end of state maintenance at the north limits of the bridge structure, a distance of 0.610 mile. (MP 0.000 to MP 0.610)

KY 10, from the Lewis County Line, extending eastward via the John Y. Brown, Jr. AA Highway to the end of state maintenance on the Ohio River bridge at the second landward pier from the river's edge in Ohio *** NOTE from the second landward pier (MP 12.419) from river's edge in Kentucky to second landward pier (MP 12.844) from the river's edge in Ohio is maintained under a maintenance contract with U.S. Government ***, a distance of 12.844 miles. (MP 0.000 to MP 12.844)

KY 67, from the Carter County Line, extending northeast to the Boyd County Line. Also, from another point on the Boyd County Line to the junction with KY 3105, a distance of 13.039 miles. (MP 0.000 to MP 1.105)(MP 1.105 to MP 13.039)

STATE SECONDARY SYSTEM

KY 1, from the Carter County Line, via Oldtown and passing near Argillite to the junction with US 23 near Greenup, a distance of 17.134 miles. (MP 0.000 to MP 17.134)

KY 2, from the Carter County Line, via Kehoe and Warnock to the junction with KY 2541, a distance of 17.463 miles. (MP 0.000 to MP 17.463)

KY 5, from the Boyd County Line to the Boyd County Line, south of the junction with US 23, a distance of 0.792 mile. (MP 0.000 to MP 0.792)

KY 7, from the junction with KY 2, northeast of Warnock, via Lynn and Maloneton to the intersection with US 23 in South Shore, a distance of 20.052 miles. (MP 0.000 to MP 20.052)

KY 8, from the Lewis County Line to the intersection with KY 8S (Spur), near S. Portsmouth, a distance of 2.000 miles. (MP 0.000 to MP 2.000)

KY 207, from the junction with KY 1 north of Argillite to the junction with US 23 in Flatwoods, a distance of 8.618 miles. (MP 9.027 to MP 17.645)

KY 693, from the junction with KY 207 in Flatwoods to the junction with US 23 in Russell, a distance of 2.713 miles. (MP 3.099 to MP 5.812)

KY 750, from the junction with KY 3105 in Raceland, via Flatwoods, to an intersection with KY 1172, via Russell, to the junction with US 23, a distance of 3.615 miles. (MP 0.000 to MP 3.615)

KY 827, from the junction with KY 7 at Lynn to the junction with US 23, a distance of 5.647 miles. (MP 0.000 to MP 5.647)

KY 1172, from the junction with KY 693 in Flatwoods to the junction with KY 750, a distance of 0.482 mile. (MP 0.000 to MP 0.482)

KY 1458, from the Boyd County Line to the junction with KY 693 in Flatwoods, a distance of 4.016 miles. (MP 0.000 to MP 4.016)

KY 1725, from the junction with KY 693 to the junction with US 23, a distance of 0.905 mile. (MP 0.000 to MP 0.905)

RURAL SECONDARY SYSTEM

KY 207, from the Carter County Line, via Hunnewell, to the junction with KY 1 at Argillite, a distance of 9.027 miles. (MP 0.000 to MP 9.027)

KY 503, from the Boyd County Line near Naples, via Naples and Danleyton to the junction with KY 207. Also, from another junction with KY 207 to the junction with KY 3105, a distance of 9.287 miles. (MP 0.000 to MP 5.481)(MP 5.481 to MP 9.287)

KY 784, from the junction with KY 1 via Samaria and Kehoe to the junction with KY 10 southwest of Letitia. Also, from another junction with KY 10 near Letitia, via Walsh to a junction with KY 7 at Sunshine, a distance of 34.710 miles. (MP 0.000 to MP 28.514)(MP 28.514 to MP 34.710)

KY 1043, from the junction with US 23 at Edgington to the junction with US 23 at Frost, a distance of 5.219 miles. (MP 0.000 to MP 5.219)

KY 1459, from the junction with KY 1 near Argillite, to the junction with KY 2, a distance of 3.366 miles. (MP 0.000 to MP 3.366)

KY 2070, from the junction with KY 784 at the Lewis County Line to the junction with KY 7, south of Lynn, a distance of 8.847 miles. (MP 0.000 to MP 8.847)

KY 2433, from the junction with KY 2 to the junction with KY 1, a distance of 2.650 miles. (MP 0.000 to MP 2.650)

KY 3306, from the junction with KY 1 to the junction with KY 207 at Hunnewell, a distance of 4.376 miles. (MP 0.000 to MP 4.376)

KY 3307, from the junction with KY 2 to the junction with US 23 near Greenup, a distance of 5.355 miles. (MP 0.000 to MP 5.355)

KY 3308, from the junction with KY 784 at Walsh to the junction with KY 7, a distance of 2.436 miles. (MP 0.000 to MP 2.436)

SUPPLEMENTAL ROADS

KY 7, from the intersection with US 23 in South Shore northwest to the junction with East First Avenue in South Shore, a distance of 0.033 mile. (MP 20.052 to MP 20.085)

KY 244, from the junction with US 23 in Russell to the north limits of the tunnel under the Russell Railroad Yard. Also, from the north limits of the tunnel under the Russell Railroad Yard in Worthington via the 0.135 mile tunnel to the south limits of the tunnel under the Russell Railroad Yard. ***Note: This 0.135 mile for road surface maintenance only*** Also, from the south limits of the tunnel under the Russell Railroad Yard in Raceland to the north limits of the tunnel under the Russell Railroad Yard in Raceland. Also, from the north limits of the tunnel under the Russell Railroad Yard, via the 0.045 mile tunnel to the south limits of the tunnel under the Russell Railroad Yard in Raceland. ***Note: This 0.045 mile for road surface maintenance only*** Also from the south limits of the tunnel under the Russell Railroad Yard in Raceland to the junction with KY 3105, a distance of 3.474 miles plus a distance of 0.180 mile (for surface maintenance only in the tunnels) for a total distance of 3.860 miles. (MP 0.000 to MP 3.258)(MP 3.258 to MP 3.393)(MP 3.393 to MP 3.458)(MP 3.458 to MP 3.503)(MP 3.503 to MP 3.860)

KY 410, from the junction with US 23 to the end of state maintenance on E. Main Street, a distance of 0.681 mile. (MP 0.000 to MP 0.681)

KY 693, from the junction with US 23 near Wurtland to the junction with KY 207 in Flatwoods, a distance of 3.099 miles. (MP 0.000 to MP 3.099)

KY 1082, from the beginning of state maintenance at the right-of-way limits of the relocated Amtrak Station in South Shore, west of the Highland Avenue overpass, extending east via Service Road #2 to the junction with US 23, a distance of 0.138 mile. (MP 0.000 to MP 0.138)

KY 1093, from the junction with KY 5 in Bellefonte to the junction with KY 1725, a distance of 1.954 miles. (MP 0.000 to MP 1.954)

KY 1711, from the junction with KY 1, extending west beyond the eastern boundary of Greenbo Lake State Park, a distance of 1.895 miles. (MP 0.000 to MP 1.895)

KY 2538, from the junction with US 23 and KY 1043 at Frost, north to the railroad, a distance of 0.105 mile. (MP 0.000 to MP 0.105)

KY 2540, from the junction with Church Street to the junction with KY 7 south of US 23 in South Shore, a distance of 0.497 mile. (MP 0.000 to MP 0.497)

KY 2541, from the junction with US 23 across from KY 1 in Greenup, including the one-way Y-junction with US 23, to the junction with US 23, 0.5 mile northwest of KY 2, a distance of 1.619 miles. (MP 0.000 to MP 1.619)

KY 2542, from US 23, east of KY 1043, via Johnson Lane, north to the railroad, a distance of 0.150 mile. (MP 0.000 to MP 0.150)

KY 2543, from the junction with US 23 in Russell to the junction with KY 244, a distance of 0.183 mile. (MP 0.000 to MP 0.183)

KY 3105, from the junction with US 23, 0.4 mile northwest of KY 503 to the junction with US 23, 0.34 mile east of KY 750 in Raceland, a distance of 3.823 miles. (MP 0.000 to MP 3.823)

KY 3112, the Bennett's Mill Covered Bridge, excluding the approaches, located on Old Tygarts Creek Road over Tygarts Creek, approximately 50 feet east of KY 7, a distance of 0.030 mile. (MP 0.000 to MP 0.030)

KY 3116, from the junction with US 23, 1.4 miles northwest of KY 827, via Lloyd and Grays Branch, to the junction with US 23, 1.01 miles north of KY 10, a distance of 3.490 miles. (MP 0.000 to MP 3.490)

KY 3117, from the junction with US 23, east of KY 1043 eastward to another junction with US 23, a distance of 0.919 mile. (MP 0.000 to MP 0.919)
