The routes as designated hereinafter were established by OFFICIAL ORDER # 85598 on September 26, 1980 and OFFICIAL ORDER # 86979 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 60, from the Daviess County Line, via Hawesville, to the Breckinridge County Line, a distance of 17.696 miles. (MP 0.000 to MP 17.696)

KY 69, from the junction with US 60 in Hawesville, via Madison Street, Main-Cross Street, Main Street, and the Lincoln Trail Bridge to the northeast end of the bridge structure *** Note: the end of the bridge is approximately 0.165 mile northeast of the Kentucky-Indiana border ***, a distance of 1.057 miles. (MP 13.080 to MP 14.137)

STATE SECONDARY SYSTEM

KY 69, from the Ohio County Line, via Weberstown, to the junction with US 60 southeast of Hawesville, a distance of 13.080 miles. (MP 0.000 to MP 13.080)

KY 144, from the Daviess County Line, via Pellville, Weberstown, Patesville, and Dukes, to the Breckinridge County Line, a distance of 12.431 miles. (MP 0.000 to MP 12.431)

KY 261, from the Ohio County Line to the Breckinridge County Line, a distance of 1.329 miles. (MP 0.000 to MP 1.329)

- KY 271, from the junction with KY 1389 northeast of Utility to the junction with US 60 northwest of Hawesville, a distance of 4.581 miles. (MP 0.000 to MP 4.581)

- KY 1389, from the Daviess County Line, via Utility, to the junction with US 60 in Hawesville, a distance of 7.929 miles. (MP 0.000 to MP 7.929)
- KY 1403, from the junction with KY 1389, north of the Daviess County Line, to the junction with KY 657, a distance of 2.485 miles. (MP 0.000 to MP 2.485)
- KY 1605, from the junction with US 60, via Adair to the junction with KY 334, a distance of 3.533 miles. (MP 0.000 to MP 3.533)
- KY 1700, from the Ohio County Line, via Easton and Victoria Crossroads, to the junction with KY 144 at Patesville, a distance of 9.196 miles. (MP 0.000 to MP 9.196)
- KY 1847, from the junction with KY 271, south of US 60, to the junction with the KY 1389 (Utility Road) in Hawesville, a distance of 2.136 miles. (MP 0.000 to MP 2.136)
- KY 2181, from the junction with KY 144 at Pellville, via Floral and Chambers to the junction with US 60 at Hawesville, a distance of 11.726 miles. (MP 0.000 to MP 11.932)

SUPPLEMENTAL ROADS

KY 334, from the Daviess County Line, via Pell Street, Fourth Street, and Market Street in Lewisport to the junction with KY 3101 (Mulberry Street) in Hawesville, a distance of 19.522 miles. (MP 0.000 to MP 19.522)

HANCOCK COUNTY

KY 1406, from the junction with US 60 extending north to Skillman Road, a distance of 1.575 miles. (MP 0.000 to MP 1.575)

KY 1957, from the junction with US 60 east of Lewisport, to the end of state maintenance at the south approach of the CSX railroad crossing, a distance of 1.225 miles. (MP 0.000 to MP 1.225)

KY 2124, from the junction with KY 261, northeast of the Ohio County Line, extending north and west to the junction with KY 1700 at Easton, a distance of 4.307 miles. (MP 0.000 to MP 4.307)

KY 3092, from the junction with KY 271 near Petrie, extending north and northeast, to the junction with KY 334, a distance of 2.039 miles. (MP 0.000 to MP 2.039)

KY 3101, from the junction with US 60 west of Hawesville, extending east via Main Street in Hawesville, to the intersection with KY 69 (Main Cross Street), a distance of 0.944 mile. (MP 0.000 to MP 0.944)

KY 3199, from the junction with US 60 in Hawesville, extending east to another junction with US 60. Also, from the junction with US 60 near Sunny Corner, extending southeast to the Breckinridge County Line, a distance of 5.558 miles. (MP 0.000 to MP 3.301) (MP 3.301 to MP 5.558)

KY 3543, from the junction with US 60 southwest of Petrie, via Petrie, to the south bank of the Ohio River opposite Tell City, Indiana, a distance of 1.991 miles. (MP 0.000 to MP 1.991)

KY 6098, ACCESS ROAD NO. 5, from a point south of US 60 that is 0.249 mile east of KY 1957 extending east to another point south of US 60 that is 0.449 mile east of KY 1957, a distance of 0.200 mile. (MP 0.000 to MP 0.200)
