# HARDIN COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state maintained system by classification in Hardin County is current as of <u>January 2, 2024</u>. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85946 on April 21, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.
