STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Jessamine County is current as of June 15, 2023. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85579 on September 26, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 27, from the Garrard County Line, via the Nicholasville Bypass and Lexington Road to the Fayette County Line, a distance of 15.278 miles. (MP 0.000 to MP 15.278)

US 68, from the Mercer County Line on the Kentucky River bridge to the Fayette County Line, a distance of 12.019 miles. (MP 0.000 to MP 12.019)

STATE SECONDARY SYSTEM

US 27X (Business), from the junction with US 27 south of Nicholasville to another junction with US 27 north of Nicholasville, a distance of 3.890 miles. (MP 0.000 to MP 3.890)

KY 29, from the intersection with KY 1268 in Wilmore to the junction with US 68. Also, from another junction with US 68 to the junction with US 27X (Business) in the Nicholasville, a distance of 5.865 miles. (MP 4.761 to MP 6.991) (MP 6.991 to MP 10.626)

KY 33, from the junction with US 68, northwest of Wilmore to the Woodford County Line, a distance of 1.262 miles. (MP 0.000 to MP 1.262)

KY 169, from the approach to the Valley View ferry on the north side of the Kentucky River near the Madison County and Fayette County Line, via Union Mills to the junction with US 27X (Business) in Nicholasville. Also, from another junction with US 27X (Business) in Nicholasville to the south limits of the bridge over the Norfolk Southern Railroad. *** Exclude the 0.017 mile Norfolk Southern Railroad Bridge *** Also, from the north limits of the bridge over the Norfolk Southern Railroad, via Keene to the Woodford County Line, a distance of 19.163 miles. (MP 0.000 to MP 10.458)(MP 10.458 to MP 10.829) (MP 10.846 to MP 19.180)

KY 1268, from the intersection with Campground Lane in Wilmore to the junction with US 68, a distance of 1.949 miles. (MP 12.062 to MP 14.011)

KY 1980, from the junction with US 68, via Brannon to the junction with US 27, a distance of 3.205 miles. (MP 0.000 to MP 3.205)

KY 2332, from the junction with KY 29 to the junction with KY 169 in Nicholasville, a distance of 0.133 mile. (MP 0.000 to MP 0.133)

KY 2827, from the junction with US 27, extending in easterly direction, to another junction with KY 39, a distance of 2.639 miles. (MP 0.000 to MP 2.639)

KY 3375, from the junction with Old US 68 to the junction with US 27, a distance of 3.199 miles. (MP 0.000 to MP 3.199)

KY 3900, from the junction with KY 1980, southwest of Fayette County Line, extending in a northwesterly direction, to the junction with E Brannon Road, the end of state maintenance, a distance of 1.681miles. (MP 0.000 to MP 1.681)

RURAL SECONDARY SYSTEM

KY 29, from the beginning of state maintenance at High Bridge to the intersection with KY 1268 in Wilmore, a distance of 4.761 miles. (MP 0.000 to MP 4.761)

KY 39, from the Kentucky River at the Garrard County Line to US 27X (Business) in Nicholasville, a distance of 9.330 miles. (MP 0.000 to MP 9.330)

KY 1267, from the Woodford County Line to the junction with KY 169 at Keene. Also, from another junction with KY 169 at Keene to the Fayette County Line, a distance of 7.508 miles. (MP 0.000 to MP 3.742)(MP 3.742 to MP 7.508)

KY 1268, from the junction with KY 39, via Pink and Little Hickman to the junction with US 27. Also, from another junction with US 27 to the intersection with Campground Lane in Wilmore, a distance of 12.062 miles. (MP 0.000 to MP 6.974)(MP 6.974 to MP 12.062)

KY 1541, from the junction with KY 39 near the Kentucky River at the Garrard County Line, via Pollard and Mt. Lebanon to another junction with KY 39 southeast of Nicholasville, a distance of 9.668 miles. (MP 0.000 to MP 9.668)

KY 1980, from the junction with US 27 to the junction with KY 1974 at the Fayette County Line, a distance of 4.246 miles. (MP 3.205 to MP 7.451)

KY 1981, from the junction with KY 1541 to the junction with KY 169. Also, from another junction with KY 169 to the Fayette County Line, a distance of 6.130 miles. (MP 0.000 to MP 3.668)(MP 3.668 to MP 6.130)

KY 3374, from the junction with US 27 near Vineyard to the junction with KY 39, a distance of 1.656 miles. (MP 0.000 to MP 1.656)

KY 3433, from the junction with KY 29 in Wilmore to another junction with KY 29 near Nicholasville, a distance of 3.594 miles. (MP 0.000 to MP 3.594)
