STATE PRIMARY ROAD SYSTEM**

The routes as designated hereinafter were established by OFFICIAL ORDER # 85709 on November 20, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

KY 8C (Connector), from the junction with KY 10 to the junction with KY 8, south of Quincy, a distance of 0.127 mile. (MP 0.000 to MP 0.127)

KY 10, from the Mason County Line, via Tollesboro to the junction with KY 9 near Ribolt, a distance of 6.788 miles. (MP 0.000 to MP 6.788)

KY 57, from the Fleming County Line to the junction with KY 10 eastbound at Tollesboro. Also, from the junction with KY 10 westbound at Tollesboro, via Covedale to the junction with KY 8 in Concord, a distance of 16.352 miles. (MP 0.000 to MP 5.129) (MP 5.129 to MP 16.352)

KY 474, from the junction with KY 59, southeast of Camp Dix to the Carter County Line, a distance of 4.922 miles. (MP 0.000 to MP 4.922)

KY 984, from the Mason County Line, via Fearisville to the junction with KY 57, a distance of 6.563 miles. (MP 0.000 to MP 6.563)

KY 989, from the Fleming County Line, via Burtonville, Nashtown, and Glen Springs to the junction with KY 9 at Charters, a distance of 12.690 miles. (MP 0.000 to MP 12.690)

KY 1021, from the junction with KY 784 at the Greenup County Line to the junction with KY 8 at Quincy, a distance of 4.328 miles. (MP 0.000 to MP 4.328)

KY 1068, from the junction of Laurel Creek Road with Tar Fork Road, to the junction with KY 59, a distance of 5.702 miles. (MP 0.000 to MP 5.702)

KY 1149, from the Carter County Line to the junction with KY 9 near Tannery. Also, from another junction with KY 9, east of Vanceburg to the junction with KY 59 in Vanceburg, a distance of 9.233 miles. (MP 0.000 to MP 7.278)(MP 7.278 to MP 9.233)

KY 3550, from the beginning of state maintenance at KY 3550 (CR 1363) to the intersection with KY 8/KY 57 in Concord, a distance of 4.550 miles. (MP 0.000 to MP 4.550)

SUPPLEMENTAL ROADS

KY 2523, from the junction with KY 9, west of Vanceburg to the junction with KY 3037, a distance of 0.424 mile. (MP 0.000 to MP 0.424)

KY 3541, from the beginning of state maintenance on Commonwealth Road to the junction with KY 2523, a distance of 0.079 mile. (MP 0.000 to MP 0.079)
