## MAGOFFIN COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state maintained system by classification in Magoffin County is current as of <u>September 17<sup>th</sup>, 2025</u>. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86760 on May 19, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

- KY 2019, from the junction with US 460, west of Salyersville, via Lickburg, to the junction with KY 1081 east of Wonnie, a distance of 5.574 miles. (MP 0.000 to MP 5.574)

- KY 3334, from the junction with KY 2019 at Lickburg to the junction with KY 1081 north of Falcon, a distance of 5.037 miles. (MP 0.000 to MP 5.037)
- KY 3337, from the junction with KY 378 near Fritz, via Right Fork-Fritz Road and Middle Fork Road to the junction with KY 30, a distance of 3.999 miles. (MP 0.000 to MP 3.999)
