This listing of the state maintained system by classification in McCracken County is current as of October 28, 2021. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85991 on May 11, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

US 62, from the Ballard County Line to the junction with US 45 in Paducah. Also, from the intersection with US 68 east of Paducah to the Marshall County Line, a distance of 14.260 miles. (MP 0.000 to MP 12.878)(MP 14.803 to MP 16.185)

KY 131, from the Graves County Line to the junction with US 62 at Reidland, a distance of 6.377 miles. (MP 0.000 to MP 6.377)
