The routes as designated hereinafter were established by OFFICIAL ORDER # 85585 on September 26, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

- KY 1822, from the Boyle County Line to the junction with US 68 at Nevada, a distance of 0.728 mile. (MP 0.000 to MP 0.728)
- KY 1915, from the Boyle County Line to the junction with US 68, a distance of 3.528 miles. (MP 0.000 to 3.528)

KY 1989, from the junction with KY 1941 in Cornishville to the junction with US 127 in Harrodsburg. Also, from another junction with US 127 in Harrodsburg to the junction with Chinn Lane, a distance of 12.870 miles. (MP 0.000 to MP 9.848) (MP 9.848 to MP 12.870)
