STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Metcalfe County is current as of October 14, 2021. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86610 on March 18, 1982 and OFFICIAL ORDER # 86989 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

LN 9008 (Louie B. Nunn Cumberland Expressway), from the Barren County Line, via Edmonton, to the Adair County Line, a distance of 13.802 miles. (MP 22.357 to MP 36.159)

KY 61, from the Adair County Line to the Adair County Line, a distance of 1.139 miles. (MP 0.000 to MP 1.139)

KY 90, from the Barren County Line, via Summer Shade, Beaumont, and Willow Shade to the Cumberland County Line, a distance of 11.661 miles. (MP 0.000 to MP 11.661)

STATE SECONDARY SYSTEM

US 68, from the Barren County Line, via Wisdom and Edmonton to the Green County Line, a distance of 20.016 miles. (MP 0.000 to MP 20.016)

KY 70, from the Barren County Line, via Knob Lick to the junction with US 68, southwest of the Green County Line, a distance of 8.869 miles. (MP 0.000 to MP 8.869)

KY 80, from the junction with US 68 in Edmonton, via Gascon to the Adair County Line, a distance of 7.888 miles. (MP 0.000 to MP 7.888)

KY 163, from the Monroe County Line, via Goodluck and Cedar Flats to the junction with US 68 in Edmonton, a distance of 11.220 miles. (MP 0.000 to MP 11.220)

KY 218, from the Hart County Line, via Shady Grove to the Green County Line, a distance of 3.451 miles. (MP 0.000 to MP 3.451)

KY 3524, from the junction with US 68 to the junction with KY 80, a distance of 1.390 miles. (MP 0.000 to MP 1.390)

KY 314, from the Barren County Line, via Savoyard and Center to the junction with KY 218 at Shady Grove, a distance of 6.463 miles. (MP 0.000 to MP 6.463)

KY 496, from the Cumberland County Line to the junction with KY 163 in Edmonton, a distance of 12.578 miles. (MP 0.000 to 12.578)

KY 533, from the junction with KY 496, east of Edmonton, via Cofer to the Adair County Line, a distance of 9.975 miles. (MP 0.000 to MP 9.975)

KY 543, from the junction with KY 1243 at Clarks Corner to the junction with US 68, a distance of 3.606 miles. (MP 0.000 to MP 3.606)

KY 544, from the junction with US 68, southwest of Cork via Cork, to the north end of the bridge over the East Fork of the Little Barren River, a distance of 3.526 miles. (MP 0.000 to MP 3.526)

KY 640, from the junction with KY 90 at Summer Shade, via Randolph and Wisdom to the junction with KY 70, west of Knob Lick, a distance of 16.723 miles. (MP 0.000 to MP 16.723)

KY 677, from the junction with KY 314, southwest of Center, to the Barren County Line, a distance of 3.368 miles. (MP 0.000 to MP 3.368)

KY 745, from the junction with US 68, northeast of the junction with KY 70, to the Green County Line, a distance of 5.064 miles. (MP 0.000 to MP 5.064)

KY 861, from the junction with KY 640 at Randolph to the junction with US 68 in Edmonton, a distance of 6.287 miles. (MP 0.000 to MP 6.287)

KY 869, from the junction with KY 70 to the junction with KY 314 near Center, a distance of 4.968 miles. (MP 0.000 to MP 4.968)

KY 1048, from the junction with KY 314 at Center, via Node to the Green County Line, a distance of 3.291 miles. (MP 0.000 to MP 3.291)

KY 2390, from the junction with KY 496 to the junction with KY 533, a distance of 2.485 miles. (MP 0.000 to MP 2.485)

KY 2399, from the junction with US 68 to the junction with KY 80 at Gascon, a distance of 2.128 miles. (MP 0.000 to MP 2.128)

KY 2435, from the junction with KY 314 at the Barren County Line to the junction with KY 70, a distance of 3.456 miles. (MP 0.000 to MP 3.456)

KY 3234, from the junction with KY 640, extending eastward and parallel with the south limits of the Louie B. Nunn Cumberland Expressway to the junction with US 68, a distance of 3.539 miles. (MP 0.000 to MP 3.539)
