## MONROE COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state-maintained system by classification in Monroe County is current as of <u>September 30, 2024</u>. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86611 on March 18, 1982. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

(MP 0.000 to MP 18.603)
- KY 249, from the junction with KY 100, via Flippin and Lamb to the Barren County Line, a distance of 4.293 miles. (MP 0.000 to MP 4.293)

KY 375, from the junction KY 163 (East Tompkinsville Bypass, south end) to junction KY 100/ KY 1446 (Magnolia Street) in Tompkinsville. Also, from another junction with KY 63/ KY 100 (Fourth Street) in Tompkinsville, via North Main Street, via Edmonton Road to the junction with KY 163 (East Tompkinsville Bypass, north end), a distance of 3.294 miles. (MP 0.000 to MP 1.459)(MP 1.459 to MP 3.294)

KY 1366, from the junction with KY 100, southeast of Flippin, via Emberton to the junction with KY 63 southwest of Tompkinsville, a distance of 9.437 miles. (MP 0.000 to MP 9.437)

KY 3144, from the junction with KY 100 in Tompkinsville extending southeast to its intersection with KY 163, a distance of 1.121 miles. (MP 0.000 to MP 1.121)

KY 382, from a junction with KY 63 in Gamaliel, via Main Street to the Tennessee State Line at Bugtussle, a distance of 6.187 miles. (MP 0.000 to MP 6.187)

KY 678, from the junction with KY 87 near the Allen County Line via Flippin, to the junction with KY 63 near Mount Hermon. Also, from another junction with KY 63, via Sulphur Lick to the junction with KY 163, south of the Metcalfe County Line, a distance of 22.605 miles. (MP 0.000 to 13.897)(MP 13.897 to MP 22.605)

KY 792, from the junction with KY 87 (West Main Street) in Gamaliel to the junction with KY 100 north of Gamaliel, a distance of 0.647 mile. (MP 0.000 to MP 0.647)
