The routes as designated hereinafter were established by OFFICIAL ORDER # 86390 on October 29, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

- KY 22, from the Grant County Line, via Doughton and Goforth to a junction with US 27 north of Falmouth. Also, from another junction with US 27 in Falmouth to the Bracken County Line, a distance of 19.237 miles. (MP 0.000 to MP 10.365)(MP 10.365 to MP 19.237)
- KY 154, from the Campbell County Line to the junction with KY 10 at Peach Grove. Also, from another junction with KY 10 at Peach Grove to the junction with KY 9

- (John Y. Brown, Jr. AA Highway), a distance of 4.489 miles. (MP 0.000 to MP 2.371)(MP 2.371 to MP 4.489)
- KY 159, from the junction with KY 22 east of Falmouth, via Concord, to the junction with KY 10 at Mount Auburn. Also, from a junction with KY 10 north of Mount Auburn to KY 9 (John Y. Brown, Jr. AA Highway), a distance of 12.928 miles. (MP 0.000 to MP 10.540)(MP 10.540 to MP 12.928)
- KY 177, from the junction with KY 159, via Butler, to the intersection with KY 467 southwest of DeMossville, a distance of 9.154 miles. (MP 0.000 to MP 9.154)
- KY 467, from the junction with KY 17 north to the junction with KY 177 at DeMossville, a distance of 0.597 mile. (MP 9.688 to MP 10.285)
- KY 2828, from the Campbell County line, via Ivor Road to the junction with KY 8, a distance of 0.532 mile. (MP 0.000 to MP 0.532)

RURAL SECONDARY SYSTEM

- KY 10, from a point on the Campbell County Line near KY 9 to another point on the Campbell County Line. Also, from a third point on the Campbell County Line, via Peach Grove, to the intersection with KY 159 north of Mount Auburn. Also, from an intersection with KY 159 at Mount Auburn, via Caddo, to the Bracken County Line, a distance of 10.893 miles. (MP 0.000 to MP 0.874)(MP 0.874 to MP 5.851)(MP 6.102 to MP 11.144)

- KY 467, from the Grant County Line, via Knoxville and Portland to the junction with KY 17 south, a distance of 9.688 miles. (MP 0.000 to MP 9.688)
- KY 491, from the Grant County Line, via Gardnersville to the junction with KY 17 east of the Kenton County Line, a distance of 4.855 miles. (MP 0.000 to MP 4.855)
- KY 609, from the junction with KY 159 at Concord to the junction with KY 177, a distance of 6.220 miles. (MP 0.000 to MP 6.220)

KY 3184, from the junction with KY 467 southwest of Portland to the junction with KY 491 at Gardnersville, a distance of 4.275 miles. (MP 0.000 to MP 4.275)

KY 3185, from the junction with KY 17 at Greenwood to the junction with KY 177 south of Butler, a distance of 2.671 miles. (MP 0.000 to MP 2.671)

SUPPLEMENTAL ROADS
