The routes as designated hereinafter were established by OFFICIAL ORDER # 86840 on July 6, 1982 and OFFICIAL ORDER # 88388 on May 11, 1984. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.
