STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Scott County is current as of June 28, 2023. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85581 on September 26, 1980 and OFFICIAL ORDER # 86995 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

**STATE PRIMARY SYSTEM**

I-64, from the Woodford County Line to the Fayette County Line, a distance of 3.894 miles. (MP 67.106 to MP 71.000)

I-75, from the Fayette County Line to the Grant County Line, a distance of 22.447 miles. (MP 120.792 to MP 143.239)

US 25, from the Fayette County Line to the intersection with US 62, a distance of 2.038 miles. (MP 0.000 to MP 2.038)

US 62, from the Woodford County Line to the intersection with US 421. Also, from the intersection with US 460B to the Bourbon County Line, a distance of 13.824 miles. (MP 0.000 to MP 0.825) (MP 5.943 to MP 18.942)

US 421, from the Fayette County Line to the junction with US 62, a distance of 0.754 mile. (MP 0.000 to MP 0.754)

US 460B, from the junction with US 460 west of Georgetown to the junction with US 62, a distance of 1.026 miles. (MP 0.000 to MP 1.026)

KY 620, from the junction with US 62, to the I-75 bridge, a distance of 2.782 miles. (MP 0.000 to MP 2.782)

KY 1143, from the intersection with US 460 (Frankfort Road) to the junction with KY 32 (Long Lick Pike), a distance of 6.929 miles. (MP 0.000 to MP 6.929)

KY 3552, from the junction with US 32, east of the intersection of US 25 and KY 32, extending eastward via I-75 Interchange, to the junction with US 62, a distance of 1.477 miles. (MP 0.000 to MP 1.477)

US 25, from the intersection with US 62 to the Grant County Line, a distance of 23.334 miles. (MP 2.038 to MP 25.372)

US 62, from the intersection with US 421, via Paynes Depot to the intersection with US 460B, a distance of 5.118 miles. (MP 0.825 to MP 5.943)

US 460, from the Franklin County Line to the Bourbon County Line (excluding the culvert over Royal Springs in Georgetown: the Transportation Cabinet maintains the roadbed, the City of Georgetown maintains the drainage), a distance of 17.658 miles. (MP 0.000 to MP 17.658)

KY 32, from the junction with US 62 in Georgetown to the intersection with US 25. Also from the west end of the Exit 136 interchange with I-75, west of Sadieville to the junction with US 25. Also, from another junction with US 25, via Sadieville to the Harrison County Line, a distance of 9.063 miles. (MP 0.000 to MP 2.314)(MP 22.662 to MP 23.003)(MP 23.003 to MP 29.411)

KY 227, from the junction with US 460, via Stamping Ground to the Owen County Line, a distance of 15.165 miles. (MP 0.000 to MP 15.165)

KY 620, from the I-75 bridge to the junction with US 25, a distance of 0.628 mile. (MP 1.505 to MP 2.133)

KY 922, from the Fayette County Line, via New Zion, to the southern intersection with KY 1962, a distance of 0.423 mile. (MP 0.000 to MP 0.423)

KY 2906, from the junction with US 460, east of I-75, via Connector Road to the junction with US 62, a distance of 1.118 miles. (MP 0.000 to MP 1.118)

### **RURAL SECONDARY SYSTEM**

KY 32, from US 25 in northern Georgetown via Skinnersburg, Longlick, Josephine, and Porter to the west end of the Exit 136 interchange with I-75, a distance of 20.348 miles. (MP 2.314 to MP 22.662)

KY 1222, from the junction with KY 1688 to the junction with Locust Fork Road, a distance of 2.454 miles. (MP 0.000 to MP 2.454)

KY 1636, from the junction with KY 620 at Biddle to the junction with KY 32, a distance of 4.269 miles. (MP 0.000 to MP 4.269)

KY 1688, from the Franklin County Line, via Watkinsville and Sand Lick to KY 227 in Stamping Ground. Also, from another junction with KY 227 in Stamping Ground to the junction with KY 32, a distance of 6.444 miles. (MP 0.000 to MP 3.894)(MP 3.894 to MP 6.444)

KY 1689, from the Franklin County Line to the junction with KY 227, north of Stamping Ground, a distance of 2.304 miles. (MP 0.000 to MP 2.304)

KY 1962, from US 62, via Clabber Bottom to the junction with KY 922, near New Zion. Also, from another junction with KY 922 to the Fayette County Line, a distance of 3.689 miles (MP 0.000 to MP 2.955)(MP 2.955 to MP 3.689)

KY 1963, from the Fayette County Line to the junction with KY 1962 at Clabber Bottom, a distance of 2.684 miles. (MP 0.000 to MP 2.684)

KY 1973, from the Fayette County Line, via Ironworks Road to the junction with US 460 near White Sulphur, a distance of 9.255 miles. (MP 0.000 to MP 9.255)

KY 2910, from 825 feet south of US 25 to the junction with US 25, south of Double Culvert, a distance of 0.155 mile. (MP 0.000 to MP 0.155)

KY 2914, from 775 feet west of I-75, via Main Street Extension to 625 feet east of I-75, a distance of 0.265 mile. (MP 0.000 to MP 0.265)

KY 6171, GREATHOUSE FRONTAGE ROAD, from the beginning of state maintenance at a point west of Cane Run Road, extending eastward along the north boundary of I-64 to the junction with Cane Run Road, a distance of 0.491 mile. (MP 0.000 to MP 0.491)
