STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Spencer County is current as of July 28, 2021. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 86170 on August 3, 1981. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

US 31E, from the Spencer County Line to the Bullitt County Line, a distance of 1.882 miles. (MP 0.000 to MP 1.882)

STATE SECONDARY SYSTEM

KY 44, from the Bullitt County Line via Waterford and Taylorsville to a point on the Shelby County Line. Also, from another point on the Shelby County Line to the Anderson County Line, a distance of 19.063 miles. (MP 0.000 to MP 17.856)(MP 17.856 to MP 19.063)

KY 48, from US 31E to a point on the Spencer County Line extending southeast. Also from another point on the Spencer County Line extending southeast to a point, a distance of 5.897 miles. (MP 0.000 to MP 1.433)(MP 1.433 to MP 5.897)

KY 55, from the Nelson County Line via Wakefield to the junction with KY 44 in Taylorsville. Also, from the junction with KY 44 in Taylorsville, to the Shelby County Line, a distance of 13.566 miles. (MP 0.000 to MP 6.518)(MP 6.518 to MP 13.566)

KY 155, from the junction with KY 55, north of Elk Creek to the Jefferson County Line, a distance of 4.247 miles. (MP 0.000 to MP 4.247)

KY 248, from the junction with KY 44 to the Anderson County Line, a distance of 7.778 miles. (MP 0.000 to MP 7.778)

KY 2239, from the junction with KY 55, via the Taylorsville Lake Dam and Spillway to the junction with KY 44, a distance of 3.831 miles. (MP 0.000 to MP 3.831)

RURAL SECONDARY SYSTEM

KY 458, from the Nelson County Line to the junction with KY 55, south of Wakefield, a distance of 0.156 mile. (MP 0.000 to MP 0.156)

KY 523, from the junction with KY 48 to the junction with US 31E, a distance of 1.376 miles. (MP 0.000 to MP 1.376)

KY 623, from the junction with KY 48 to the junction with KY 44, east of Waterford, a distance of 6.087 miles. (MP 0.000 to MP 6.087)

KY 636, from the junction with KY 248 to the Shelby County Line near Mt. Eden, a distance of 3.608 miles. (MP 0.000 to MP 3.608)

KY 652, from the Nelson County Line to the junction with KY 55, a distance of 6.185 miles. (MP 0.000 to MP 6.185)

KY 1060, from the junction with KY 44 at Waterford to the junction with KY 1319, a distance of 5.169 miles. (MP 0.000 to MP 5.169)

KY 1066, from the Nelson County Line to the junction with KY 55 near the Nelson County Line, a distance of 4.122 miles. (MP 0.000 to MP 4.122)

KY 1169, from the junction with KY 1060 north of Waterford, via Normandy, to the end of state maintenance, a distance of 8.916 miles. (MP 0.000 to MP 8.916)

KY 1251, from the junction with KY 44 to the junction with KY 1060, a distance of 4.226 miles. (MP 0.000 to MP 4.226)

KY 1319, from a point on the Bullitt County Line extending northeast to another point on the Bullitt County Line, near the junction with KY 1060. Also, from another point on the Bullitt County Line to the junction with KY 3192, a distance of 4.488 miles. (MP 0.000 to MP 2.145)(MP 2.145 to MP 4.488)

KY 1416, from the junction with KY 248 to the junction with KY 1795, a distance of 4.396 miles. (MP 0.000 to MP 4.396)

KY 1633, from the junction with KY 44, west of Taylorsville to the junction with KY 55 near Elk Creek, a distance of 6.102 miles. ***Including maintenance of a 0.117 mile connector at mile point 3.826 to KY 55; no mileage carried*** (MP 0.000 to MP 6.102)

KY 1795, from the junction with KY 44 at Little Mount to the junction with KY 636 in Mount Eden, a distance of 5.991 miles. (MP 0.000 to MP 5.991)

KY 2450, from the junction with KY 1066 north of the Nelson County Line, extending northwest to the end of state maintenance near Taylorsville Lake, a distance of 3.599 miles. (MP 0.000 to MP 3.599)

KY 2885, from the junction with KY 652 to the junction with KY 55 south of Taylorsville, a distance of 7.008 miles. (MP 0.000 to MP 7.008)

KY 3192, from the junction with KY 1633 at Elk Creek to the junction with KY 155, a distance of 2.950 miles. (MP 0.000 to MP 2.950)

KY 1392, from the Nelson County Line to the junction with KY 55, a distance of 4.572 miles. (MP 0.000 to MP 4.572)

KY 2814, from the beginning of state maintenance on Whitfield Lane (CR 1152) to the Bullitt County Line, a distance of 1.404 miles. (MP 0.000 to MP 1.404)

KY 3200, from the junction with KY 44 in Taylorsville, extending east to the junction with KY 44, east of Taylorsville, a distance of 1.490 miles. (MP 0.000 to MP 1.490)

KY 3228, from the beginning of state maintenance at a barricade at the U.S. Army Corps of Engineers' Property Line, extending eastward (including a realigned connector roadbed to KY 248) to the junction with KY 248, a distance of 2.321 miles. (MP 0.000 to MP 2.321)

KY 3230, from the beginning of state maintenance at the State Park Service Road entrance, extending east to the junction with KY 248, a distance of 0.120 mile. (MP 0.000 to MP 0.120)
