STATE PRIMARY ROAD SYSTEM**

This listing of the state maintained system by classification in Trigg County is current as of September 01, 2021. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85993 on May 11, 1981 and OFFICIAL ORDER # 86997 on August 12, 1982. Revisions to the original official orders are given at the end of this route listing. The revisions are in numerical order by route affected.

STATE PRIMARY SYSTEM

I-24, from the Caldwell County Line to the Christian County Line, a distance of 12.441 miles. (MP 57.389 to MP 69.830)

US 68, from the Marshall County Line via Fenton, Golden Pond, Canton, and the Cadiz Bypass to the Christian County Line, a distance of 28.029 miles. (MP 0.000 to MP 28.029)

STATE SECONDARY SYSTEM

KY 139, from the Tennessee State Line via Hamilton Street and Jefferson Street in Cadiz, to the Caldwell County Line at Black Hawk, a distance of 24.620 miles. (MP 0.000 to MP 24.620)

KY 164, from the intersection with KY 139 via Roaring Spring to the Christian County Line, a distance of 8.600 miles. (MP 18.040 to MP 26.640)

RURAL SECONDARY SYSTEM

KY 124, from the junction with KY 139 near Cadiz, via Cerulean, to the Christian County Line, a distance of 12.136 miles. (MP 0.000 to MP 12.136)

KY 126, from the junction with KY 128 northwest of Buffalo to the junction with KY 124 in Cerulean. Also, from another junction with KY 124 in Cerulean to the Caldwell County Line, a distance of 5.257 miles. (MP 0.000 to MP 2.231)(MP 2.231 to MP 5.257)

KY 128, from the junction with US 68 via Buffalo and Wallonia to the Caldwell County Line, a distance of 11.109 miles. (MP 0.000 to MP 11.109)

KY 164, from the junction with US 68 at Canton via Linton to the intersection with KY 139, a distance of 18.04 miles. (MP 0.000 to MP 18.040)

KY 272, from the junction with US 68 via Caledonia to the Christian County Line, a distance of 12.049 miles. (MP 0.000 to MP 12.049)

KY 274, from the junction with US 68X (Business), southwest of Cadiz, via Trigg Furnace to the Lyon County Line, a distance of 10.967 miles. (MP 0.000 to MP 10.967)

KY 276, from the junction with KY 274 to the junction with KY 139 south of Black Hawk. Also, from the Caldwell County Line to the junction with KY 128 west of Wallonia. Also, from another junction with KY 128 at Wallonia to the junction with US 68 west of the US 68 interchange with I-24, a distance of 14.121 miles. (MP 0.000 to MP 5.888)(MP 5.888 to 8.701)(MP 8.701 to MP 14.121)

KY 525, from the junction with KY 164 west of Roaring Spring to the junction with KY 139, a distance of 9.370 miles. (MP 0.000 to MP 9.370)

KY 624, from the junction with KY 124 in Cerulean to the Christian County Line, a distance of 2.995 miles. (MP 0.000 to MP 2.995)

KY 778, from the junction with KY 139 in Cadiz, via Brown Street, Wallace Avenue, and Will Jackson Road to the junction with KY 276. Also, from another junction with KY 276 to the Lyon County Line, a distance of 9.052 miles. (MP 0.000 to MP 8.193)(MP 8.193 to MP 9.052)

KY 807, from the junction with KY 164 via Donaldson to the junction with KY 139, a distance of 5.743 miles. (MP 0.000 to MP 5.743)

KY 1062, from the junction with KY 807 at Donaldson via Maple Grove to the junction with KY 272, a distance of 5.316 miles. (MP 0.000 to MP 5.316)

KY 1253, from the junction with KY 525 to the junction with KY 272 west of Caledonia, a distance of 6.179 miles. (MP 0.000 to MP 6.179)

KY 1489, from the junction with US 68 east of Canton extending north and east via Lake Barkley State Resort Park to another junction with US 68, a distance of 5.262 miles. (MP 0.000 to MP 5.262)

KY 1585, from the Christian County Line, via Caledonia Pee Dee Road, South Montgomery Road, and North Montgomery Road to the junction with US 68 west of the US 68 interchange with I-24, a distance of 9.731 miles. (MP 0.000 to MP 9.731)

SUPPLEMENTAL ROADS

US 68X (Business), from the junction with US 68 southeast of Cadiz, to another junction with US 68 in Cadiz, a distance of 4.543 miles. (MP 0.000 to MP 4.543)

KY 918, from the junction with Mount Pleasant Church Road at Blue Spring to the junction with KY 1489 near Lake Barkley State Resort Park, a distance of 0.504 mile. (MP 0.000 to MP 0.504)

KY 929, from the junction with KY 139 in Cadiz, via Marion Street to the junction with US 68X (Business), a distance of 0.046 mile. (MP 0.000 to MP 0.046)

KY 958, from the junction with US 68 east of the I-24 interchange to the junction with KY 276, a distance of 4.226 miles. (MP 0.000 to MP 4.226)

KY 1175, from the junction with KY 272 to the junction with US 68X (Business) southwest of Cadiz, a distance of 1.976 miles. (MP 0.000 to MP 1.976)

KY 1507, from the junction with KY 958 to the junction with KY 128 northwest of Buffalo, a distance of 2.189 miles. (MP 0.000 to MP 2.189)

KY 1891, from the beginning of state maintenance at the U.S. Army Corps of Engineers Boundary at Lake Barkley, extending northward to the junction with KY 164 southeast of Canton, a distance of 3.316 miles. (MP 0.000 to MP 3.316)

KY 3186, from the junction with US 68 to the Christian County Line, a distance of 0.169 mile. (MP 0.000 to MP 0.169)

KY 3468, from the junction with US 68, east of US 68X (Business), following along Old US 68 to another junction with US 68, west of KY 276 and KY 1585, a distance of 2.840 miles. (MP 0.000 to MP 2.840)

KY 3568, from the beginning of state maintenance 0.267 miles southwest of the junction with US 68 Connector (Old Canton Road Connector), extending northeaster along Old US 68, to the end of state maintenance. Also, from a new junction with US 68, on the south side of US 68, lying northeast of Sam Downs Road, extending east and northeasterly along old US 68 / KY 80, to the end of state maintenance. Also from the beginning of state maintenance 0.168 southwest of the junction with KY 1489, following along Old US 68 (Old Canton Road), to a new junction with US 68, a distance of 4.151 miles. (MP 0.000 to MP 0.493) (MP 0.493 to MP 3.065) (MP 3.065 to MP 4.151)

KY 6049, BUSH ROAD, from the beginning of state maintenance 0.084 mile southwest of I-24 to the junction with KY 6050 (Nickys Lane), a distance of 0.277 mile. (MP 0.000 to MP 0.277)

KY 6050, NICKYS LANE, from the junction with KY 6049 (Bush Road) near the north limits of the I-24 Underpass to the end of state maintenance, a distance of 0.292 mile. (MP 0.000 to MP 0.292)

KY 6051, ADAMS MILL ROAD, from the beginning of state maintenance 0.116 mile southwest of I-24 to another point 0.497 mile northeast of I-24, a distance of 0.613 mile. (MP 0.000 to MP 0.613)

KY 6052, FRONTAGE ROAD #9, from the junction with KY 276 near the south limits of I-24, extending northwest for a distance of 0.237 mile. (MP 0.000 to MP 0.237)

KY 6053, EDWARDS CEMETERY ROAD, from the junction with KY 276 near the north limits of I-24, extending southeasterly for a distance of 0.613 mile. (MP 0.000 to MP 0.613)

KY 6054, HERNDON ROAD, from the beginning of state maintenance north of the I-24 Interchange and west of US 68, extending eastward to the junction with US 68, a distance of 0.075 mile. (MP 0.000 to MP 0.075)

KY 6056, WRIGHT LANE, from the junction with KY 6058 (Old Hopkinsville Road) east of I-24, extending northward for a distance of 0.163 mile. (MP 0.000 to MP 0.163)

KY 6057, SMITH LANE, from the beginning of state maintenance south of KY 6058 (Old Hopkinsville Road), extending northward and parallel with the west limits of I-24 to the junction with KY 6058, a distance of 0.973 mile. (MP 0.000 to MP 0.973)

KY 6058, OLD HOPKINSVILLE ROAD, from the beginning of state maintenance 0.167 mile west of I-24 to another point 0.133 mile east of I-24, a distance of 0.300 mile. (MP 0.000 to MP 0.300)

KY 6059, from the junction with US 683 (Bypass/Hopkinsville Road), extending north and west to the end of state maintenance, a distance of 0.115 mile. (MP 0.000 to MP 0.115)
