## WOODFORD COUNTY STATE PRIMARY ROAD SYSTEM

This listing of the state maintained system by classification in Woodford County is current as of <u>December 1, 2021</u>. Any listing of an earlier date should be discarded. Additional listings can be obtained from the DIVISION OF PLANNING, ROADWAY SYSTEMS TEAM.

The routes as designated hereinafter were established by OFFICIAL ORDER # 85583 on September 26, 1980. Revisions to the original official order are given at the end of this route listing. The revisions are in numerical order by route affected.

#### **STATE PRIMARY SYSTEM**

I-64, from the Franklin County Line to the Scott County Line, including the bridges over South Elkhorn Creek, a distance of 7.675 miles. (MP 59.431 to MP 67.106)

BG 9002 (Martha Layne Collins Bluegrass Parkway), from the Anderson County Line on the Kentucky River Bridge to the junction with US 60, a distance of 9.187 miles. (MP 61.947 to MP 71.134)

US 60, from the Franklin County Line via the Versailles Bypass to the west end of the Shannons Run Bridge at the Fayette County Line, a distance of 13.039 miles. (MP 0.000 to MP 13.039)

US 62, from the junction with US 421 in Midway to the South Elkhorn Bridge at the Scott County Line, a distance of 2.342 miles. (MP 14.117 to MP 16.459)

US 421, from the junction with US 62 in Midway to the Franklin County Line, a distance of 4.931 miles. (MP 0.000 to MP 4.931)

#### STATE SECONDARY SYSTEM

US 60X (Business Route), from the junction with US 60 on the north side of Versailles, via Frankfort Street, North Main Street, and Lexington Street in Versailles to the junction with US 60 on the east side of Versailles, a distance of 1.790 miles. (MP 0.000 to MP 1.790)

#### **WOODFORD COUNTY**

- US 62, from the Anderson County Line on the Kentucky River Bridge to the junction with US 60X (Business) in Versailles. Also, from the junction with US 60 just north of Versailles to the junction with US 421 in Midway, a distance of 14.117 miles. (MP 0.000 to MP 7.048)(MP 7.048 to MP 14.117)
- KY 33, from the Jessamine County Line south of Troy, via Troy and via South Main Street in Versailles to the junction with US 62, a distance of 13.799 miles. (MP 0.000 to MP 13.799)
- KY 169, from the Jessamine County Line, southeast of Pinckard, via Pinckard to the junction with KY 33, south of the Martha Layne Collins Bluegrass Parkway, a distance of 4.474 miles. (MP 0.000 to MP 4.474)
- KY 1681, from the Franklin County Line, via Duckers, Nugent Crossroads, and Faywood to the Fayette County Line, a distance of 10.900 miles. (MP 1.425 to MP 12.325)
- KY 2113, from the junction with KY 33, extending northwest to the junction with US 62, a distance of 2.041 miles. (MP 0.000 to MP 2.041)

#### **RURAL SECONDARY SYSTEM**

- KY 341, from the junction with US 62 in Midway to the Scott County Line (including South Elkhorn Bridge), a distance of 1.351 miles. (MP 0.000 to MP 1.351)
- KY 1267, from the junction with KY 33 at Troy to the Jessamine County Line, a distance of 0.130 mile. (MP 0.000 to MP 0.130)
- KY 1659, from the junction with US 60X (Business) in Versailles via Millville to the Franklin County Line, a distance of 11.560 miles. (MP 0.000 to MP 11.560)
- KY 1681, from the junction with KY 1659 at Millville to the Franklin County Line, a distance of 1.425 miles. (MP 0.000 to MP 1.425)
- KY 1685, from the junction with US 62 at Milner, via McKees Crossroads, to the junction with KY 1681. Also, from another junction with KY 1681 via Spring Station to the Franklin County Line, a distance of 12.473 miles. (MP 0.000 to MP 9.018)(MP 9.018 to MP 12.473)
- KY 1964, from the east bank of the Kentucky River to the junction with US 62 in Versailles. Also, from another junction with US 62 in Versailles via Clifton to the junction with KY 1659 south of Millville, a distance of 19.171 miles. (MP 0.000 to MP 9.745)(MP 9.745 to MP 19.171)

#### **WOODFORD COUNTY**

KY 1965, from the junction with KY 33 via Nonesuch and Mortonsville to the junction with KY 1964, west of Mortonsville, a distance of 9.374 miles. (MP 0.000 to MP 9.374)

KY 1966, from the junction with KY 1967 to the Fayette County Line, a distance of 0.694 mile. (MP 0.000 to MP 0.694)

KY 1967, from the junction with KY 169, north of Pinckard to the junction with KY 1681, west of Faywood, a distance of 9.010 miles. (MP 0.000 to MP 9.010)

KY 3360, from the junction with KY 1659 to the junction with US 60, a distance of 2.590 miles. (MP 0.000 to MP 2.590)

KY 3361, from the junction with US 60 to the Franklin County Line, a distance of 0.240 mile. (MP 0.000 to MP 0.240)

KY 2331, from the junction with KY 1659 to the junction with KY 1685, a distance of 0.797 mile. (MP 0.000 to MP 0.797)
