PURPOSE AND NEED	In 1995, the Kentucky Transportation Cabinet completed a study of US 51 from Fulton to Wickliffe, which concluded that improvements were not justified for the entire route, but new bypass routes were needed at Clinton and Bardwell to relieve congestion and reduce truck traffic in those two cities.
