**I. PROJECT DESCRIPTION**

Project Description – Bridge Replacement

Bridge Number 09100005N at MP 1.799 over North Fork Somerset Creek, approximately 1.8 miles North of KY 57. The bridge is 25 ft long built in the 30's

**III. PURPOSE AND NEED**

The purpose of this project is to replace a bridge and its approaches on KY 1285 between MP 1,7 and MP 1.9 over North Fork Somerset Creek. The project is necessary to replace one two-lane bridge which is dilapidated and structurally deficient. The bridge has been assessed a sufficiency rating of 33.9. KY 1285 is a Rural Minor Collector with a 2008 ADT of 484.

**V. SCOPE OF WORK**

The selected Consultant will be required to provide Phase I and Phase II Roadway Design, including the preparation of preliminary line and grade plans, drainage design, right-of-way plans, construction plans, traffic control plans, and cost estimates. The selected consultant will also be required to provide engineering services to perform Structure Design.


#### **XVI. EVALUATION FACTORS**

4. Project approach and proposed procedures to accomplish the services for the project. (10 points)
5. Consultant's offices where work is to be performed. (2 points)

For state-funded projects, if a Selection Committee vote results in a tie between two (2) firms, one (1) of which will perform more of the work tasks in Kentucky than the other, then the former firm shall be ranked one (1) place ahead of the latter.
