

# A REQUEST FOR PROPOSAL FOR PERSONAL SERVICES CONTRACT

## Department of Highways Professional Services Procurement Bulletin 2011-12 Statewide Environmental Storm Water

This document constitutes a Request for Proposals for Personal Service Contract from qualified individuals and organizations to furnish those services as described herein for the Commonwealth of Kentucky, Department of Highways.

### **I. PROJECT DESCRIPTION**

Project Description – Environmental Storm Water and Technical Support

### **II. PROJECT INFORMATION**

Approximate Fee – \$1,000,000.00 Fees to be determined by letters of agreement  
Project Funding – State Funds  
Contract Duration – 2 years.

### **III. PURPOSE AND NEED**

Continue development of the Kentucky Pollution Discharge Elimination system (KPDES) + 404/401 programs for KYTC and to provide technical support for facility management and highway maintenance operations required by all environmental programs.

### **IV. DBE REQUIREMENT**

None

### **V. SCOPE OF WORK**

Review and preparation of permits, plans, and related documents for Clean Water Act-KPDES permits. Ground Water Protection Plans (GWPP), 401/404 permits, Spill Prevention Control Countermeasure (SPCC) plans, herbicide usage, and environmental issues. Scope of work will involve tasks related to improvement or support of the Storm Water Program. These include:

- 404/401 permits
- Review and modify as needed, facility Storm water Pollution Prevention Plans (SWPPP) and Groundwater Protection Plans (GWPP).
- KPDES Permit preparation, submittal, and follow through.
- Advise and prepare documents for KYTC to comply with the MS4 Program,
- Provide training and manuals for KYTC staff for compliance with the Clean Water Act; and
- Advise and prepare documents for KYTC to comply with the Clean Water Act.

The consultant will need to have a thorough understanding of the Clean Water Act, KPDES program, sedimentology, and hydrology.
