Improvement Program (TIP) and Administrative Modification #51 to the 2045

Metropolitan Transportation Plan (MTP)

On June 16, 2023, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #33 to the FY 2021 – 2024 TIP and Modification #51 to the 2045 MTP.

Administrative Modification #31:

This modification adds one new Grouped Project* (Bike/Ped facilities), which does not impact the financial constraint of the TIP:

Brighton Trail Connection:

This modification adds a project to connect the existing trail in Liberty Park to the sidewalk along the east side of Liberty Rd funded with federal STBG-TA funds (aka TAP) administered through the statewide TAP program.

\$576,000 federal STBG-TA funds + 144,000 local match = \$720,000

* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).
