The Bowling Green-Warren County Metropolitan Planning Organization (MPO) hereby modifies the FY 2024-2028 Transportation Improvement Program (TIP). This modification reflects the authorization of Federal Lands Access Program (FLAP) funding for a regional planning study for a shared-use trail between Bowling Green in Warren County and Mammoth Cave National Park in Edmonson County.

<u>DESCRIPTION:</u> Planning Study to assist agencies at the regional level to identify the best and most preferred location of a shared-use approximate 23-mile trail between Downtown Bowling Green and the existing Mammoth Cave National Park Rail Trial in Park City.

<u>Other Information</u>: This TIP Modification amends projects and funding levels listed in Table 2 (*Summary of Funding*), Table 4 (*Federally Funded Projects*), and Table 9 (*Projects Contributing to the Achievement of Highway Performance Targets*) of the FY 2024-2028TIP. The changes in this Modification reference projects listed in the 2045 Metropolitan Transportation Plan (MTP) Table 6.4 (*Grouped Projects*) and therefore maintains consistency between the MTP and TIP documents. Additional funding beyond that previously identified in the TIP has been committed to these projects by the Federal Highway Administration. This funding maintains financial constraint of the TIP and MTP documents, and no additional financial constraint analysis by the MPO is needed.
