Improvement Program (TIP) and Administrative Modification #62 to the 2045

Metropolitan Transportation Plan (MTP)

On February 2, 2024, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #44 to the FY 2021 – 2024 TIP and Modification #62 to the 2045 MTP.

Administrative Modification #44:

This action updates the previously published documents and tables. This modification makes a minor change to the project limits for one grouped¹ project, which does not impact the financial constraint of the TIP. This modification does not make any changes to the project budget or timeline.

Richmond Rd RCUTs:

This modification extends the eastern project terminus on KY 418 from MP 2.489, on the west side of I-75, to MP 2.6, on the east side of I-75. This extension of approximately 580 will allow the contractor to extend conduit and wire to connect the traffic signal on the east side of I-75.
