On April 5, 2024, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #47 to the FY 2021 – 2024 TIP and Modification #65 to the 2045 MTP.

Administrative Modification #47:

This action updates the previously published documents and tables. This modification increases the STBG-SLX funding for two existing ongoing programs in FY 2024 to allow implementation of these programs to carry over into FY 2025 prior to the FY 2025-2028 TIP, which should be adopted in August, 2024 and go into effect on October 1, 2024.

Intelligent Transportation Systems (ITS)

Increase the FY 2024 allocation from \$600,000 to \$1,200,000 (\$960,000 in Federal STBG-SLX (80%) + \$240,000 Local Match (20%))

Various Continuing Programs

Increase the FY 2024 allocation from \$555,000 to \$1,121,250 (\$897,000 in Federal STBG-SLX (80%) + \$224,250 Local Match (20%))
