The Kentucky Transportation Cabinet has scheduled a Public Information Meeting to review possible alternatives and potential impacts for a proposed highway project to improve the transportation corridor between Vanceburg and Morehead. The study involves the routes of KY 59, KY 344 and KY 377 from KY 9 (AA Highway) in Vanceburg to KY 799 (Big Perry Road) in the community of Triplett in Rowan County. The Transportation Cabinet wishes to solicit the public's input on the study and any impacts related to the improvement of the study corridor.

The public meeting will be held from 5:30 PM to 7:30 PM. Transportation Cabinet and consultant representatives will be available to receive comments and respond to questions. The meeting will be conducted in an open format, meaning that interested parties may attend at any point in the meeting's duration.

Both written and oral statements will be accepted at the meeting. A recording device will be made available for those who desire to make oral statements, and a comment sheet will be distributed to make it more convenient to provide written comments.

Written statements will be accepted at the meeting and for a period of 15 days after the Public Information Meeting.
