

SUBJECT: Notification of **Administrative Modification #10** to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #29 to the 2045 Metropolitan Transportation Plan (MTP)

On December 17, 2021, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #10 to the FY 2021 – 2024 TIP and Modification #29 to the 2045 MTP.

Administrative Modification #10:

This action updates the previously published documents and tables. This modification is considered Grouped Projects* (Highway Safety Improvement Program) which does not impact the financial constraint of the TIP. The modification adds the following safety project in Jessamine County:

- **US 68 Low Cost Safety Improvements from MP 0.000 (KY River) - MP 4.807 (Wilmore Y)**
 - \$1,890,900 (90% Federal HSIP funds) + \$210,100 (10% State Match) = \$2,101,000
