**SUBJECT:** Notification of Administrative Modification #12 to the FY 2021 – FY 2024 Transportation Improvement Program (TIP) and Administrative Modification #31 to the 2045 Metropolitan Transportation Plan (MTP)

---

On January 28, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #12 to the FY 2021 – 2024 TIP and Modification #31 to the 2045 MTP.

### Administrative Modification #12:

This action updates the previously published documents and tables. This modification is considered Grouped Projects\* (Highway Safety Improvement Program) which does not impact the financial constraint of the TIP. The modification adds the following five safety projects (4 in Fayette County and 1 in Jessamine County):

- **US 27 @ Loudon Av Vicinity Safety Improvements**
  - \$99,000 (90% Federal HSIP funds) + \$11,000 (10% State Match) = \$110,000
- **US 68 @ Ft Harrods Dr Vicinity Safety Improvements**
  - \$342,000 (90% Federal HSIP funds) + \$38,000 (10% State Match) = \$380,000
- **Man O' War @ Parkers Mill Rd Vicinity Safety Improvements**
  - \$45,000 (100% Federal HSIP funds)
- **KY 4 @ Russell Cave Rd Vicinity Safety Improvements**
  - \$112,500 (90% Federal HSIP funds) + \$12,500 (10% State Match) = \$125,000
- **US 27 @ Edgewood Dr Vicinity Safety Improvements (Jessamine Co)**
  - \$220,500 (90% Federal HSIP funds) + \$24,500 (10% State Match) = \$245,000

*\* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).*
