ACTION:

The Radcliff/Elizabethtown Metropolitan Planning Organization (MPO) hereby modifies the FY 2022-2026 Transportation Improvement Program (TIP) to reflect the following change:

- Transit Authority of Central Kentucky (TACK) – Building Refurbishment – Replacement, Re-sealing, and Resurfacing of damaged exterior brick; Replace guttering; Correct water drainage and sewer failures; Replace old or obsolete electrical wiring, lighting, breakers, and other electrical issues; Install coverings over exterior entrance doors; and Install new identification lettering and signage. Federal (Section 5307) = \$362,303; Match = \$90,575; TOTAL = \$452,878
- TACK Training Center – Creation of a training center and meeting area within the existing TACK transit facility. Federal (Section 5339) = \$611,611; Match = \$152,903; TOTAL = \$764,514
- TACK Purchase of Real Property – Brandenburg, Meade County – TACK will seek to purchase between 1 and 3 acres in or around Brandenburg to provide parking for TACK vehicles that operate in Meade County. If the funding allows, chain link fence and security gate will be installed around the property to provide protection against vandalism and theft. Federal (Section 5339) = \$98,080; Match = \$19,616; TOTAL = \$117,600
- TACK Purchase and Installation of a Business Sign - Federal (Section 5339) = \$48,876; Match = \$12,219; TOTAL = \$61,095

Construction or Renovation of Transit Facilities projects are classified as Grouped Projects in the TIP; therefore a formal amendment is not necessary.

Funding has been approved or identified for these projects; therefore a new fiscal constraint analysis by the MPO is not necessary.
