Metropolitan Transportation Plan (MTP)

On March 22, 2022, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #16 to the FY 2021 – 2024 TIP and Modification #35 to the 2045 MTP.

Administrative Modification #16:

This action updates the previously published documents and tables. This modification is considered Grouped Projects* (Purchase of new buses) which does not impact financial constraint of the TIP. The modification adds the following project, funded through a Federal Transit Administration (FTA) Grant for Buses and Bus Facilities:

Lextran: Purchase Four Electric Buses, Chargers and a Charging Depot:

\$4,107,642 (80% FTA Grant for Buses & Bus Facilities) + \$1,026,910 (20% Local match) = \$5,134,552
