Improvement Program (TIP) and Administrative Modification #53 to the 2045

Metropolitan Transportation Plan (MTP)

On July 18, 2023, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #35 to the FY 2021 – 2024 TIP and Modification #53 to the 2045 MTP.

Administrative Modification #35:

This modification adds one new Grouped Project* (Planning and Technical Studies), which does not impact the financial constraint of the TIP:

US 68 Safety Improvements Study:

This modification adds a feasibility study to improve safety and driver expectations on US 68 (Harrodsburg Road) near the Kentucky River. The study area is a 6.998 mile section of US 68 from the Shakertown Entrance in Mercer County (MP 14.45) to Pekin Pike in Jessamine County (MP 1.380). This modification commits \$250,000 for the study, including \$200,000 in federal National Highway (NHPP) funds with a \$50,000 state match. No local funds are required.

* The identification of Grouped Projects involves a commitment of additional funding by the project sponsor. The additional funding maintains financial constraint of these documents. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review, demonstration of fiscal constraint, or a conformity determination (if applicable).
