SUBJECT: Notification of Administrative Modification #42 to the FY 2021 - FY 2024 Transportation

Improvement Program (TIP) and Administrative Modification #60 to the 2045

Metropolitan Transportation Plan (MTP)

On January 9, 2024, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #42 to the FY 2021 – 2024 TIP and Modification #60 to the 2045 MTP.

Administrative Modification #42:

This action updates the previously published documents and tables. This modification moves STBG-TA funding between phases for one grouped project and adds recently awarded state STBG-TA funding to another grouped project, which does not impact the financial constraint of the TIP.

Alumni Drive Shared Use Trail:

This modification moves \$328,000 (\$262,000 in Federal STBG-TA (80%) + \$66,000 Local Match (20%)) from the Construction phase, which is scheduled in 2025, to the Design phase to cover cost increases.

Armstrong Mill Bike/Ped Improvements:

This modification adds \$1,000,000 (\$800,000 in Federal STBG-TA (80%) + \$200,000 Local Match (20%)) to the Construction phase.
