SUBJECT: Notification of Administrative Modification #48 to the FY 2021 - FY 2024 Transportation

Improvement Program (TIP) and Administrative Modification #1 to the 2050 Metropolitan

Transportation Plan (MTP)

On May 14, 2024, the Lexington Area Metropolitan Planning Organization issued Administrative Modification #48 to the FY 2021 – 2024 TIP and Modification #1 to the 2050 MTP.

Administrative Modification #48:

This modification adds one new Grouped Project¹ (Highway Safety Improvement Program projects), which does not impact the financial constraint of the TIP:

KY 1966 Safety Improvements

This modification adds the right of way and utility phases for a project to implement low cost safety improvements on KY 1966 (Military Pike) near the Fayette/Woodford County Line.

• 90% federal HSIP funds (\$630,000) + 10% state match (\$70,000) = \$700,000

The construction phase of \$2,000,000 (\$1,800,000 HSIP = \$200,000 state match) is scheduled for FY 2025, which is beyond the current TIP years. It will be added to the upcoming TIP update.
