METHOD OF DESIGN	The selected consultant shall utilize the CADD Standards for Highway Plans (version 2.0) policy in the development of the Highway Plans.

PROJECT FUNDING	State Funds
SCOPE	Conduct preliminary engineering studies to identify line and grade for a new Industrial Access Road from KY55 to the Shawnee Industrial Park to improve safety and relieve congestion on existing Mulberry Pike. This will include traffic flow analysis, typical section, line and grade, dependable cost estimates, identifying right of way and utility conflicts and possible mitigation, identify drainage issues, traffic control considerations, necessary structure modifications, and possible enhancements to signing and pavement markings. The Cabinet will prepare the appropriate environmental document.
ENVIRONMENTAL	Department will provide all required environmental services.
PHOTOGRAMMETRIC SERVICES	The Department will provide aerial mapping or request the consultant to field survey the project.
STRUCTURE DESIGN	<p>Department</p> <p>If necessary the selected consultant shall do the necessary engineering services to submit to the Kentucky Transportation Cabinet an Advance Situation Folder(s) for the appropriate applicable structure(s).
