PURPOSE AND NEED	Improve safety, traffic operation, and congestion on KY 22 by reconstructing the intersections with Ten Broeck Way, Springcrest Drive, Goose Creek Road, Barbour Lane, The Avenue of the Woods/Chattsworth Lane, and Herr Lane.
PROJECT LENGTH	>1 Mile
METHOD OF DESIGN	The Selected Consultant shall utilize the CADD Standards for Highway Plans (version 2.04) policy in the development of the highway plans.
DBE REQUIREMENT	None

AVAILABLE STUDIES	<u>KY 22 Scoping Study</u> in Jefferson and Oldham Counties, prepared by HNTB Corporation, October 2005.
SCOPE	Includes preliminary engineering and final design. Develop 6 individual sets of final plans to implement the recommended safety improvements for each of the 6 respective KY 22 intersections. This will include traffic flow analysis, typical section, line and grade, dependable cost estimates, identifying right-of-way and utility conflicts and possible mitigation, identify drainage issues, traffic control considerations, necessary structure modifications, and possible enhancements to signing and pavement mark-
