**Fayette Co. US 68**

**QUESTION NO. 1) Project length is listed as 1.4 miles which is much longer than the described limits of Corporate Drive to Alexandria Drive. Is it possible the ending terminus is intended to be Lane Allen Road rather than Alexandria Drive?**

**ANSWER: Project ends at Alexandria Dr. Project originally had different limits. Description has changed but project length wasn't adjusted in Oracle Pre-construction data base.**

**QUESTION NO. 2) Can the hyperlink for the maps be activated?**

**ANSWER: The corrected static map attached and a link to the IMS map for this project.**

**QUESTION NO. 3) Prequalification requirement is "Urban Roadway Design less than \$250,000", approximate fee listed as \$300,000. Is this correct?**

**ANSWER: Prequalification for Roadway Design should be Urban Design >250,000.**

**QUESTION NO. 1) Scope: The selected consultant will provide engineering services for Phase I, Phase II and Environmental document. However, we have no Prequalification requirement for Environmental. Will the Consultant provide environmental services and if so what type of document?**

**ANSWER: Consultant to provide environmental services for a C.E.**

## Regional Highway & Bridge Construction Inspection

**QUESTION NO. 1:** Hours per week to be used for proposed tech work? Last year it was based on 40 hours straight time, 10 hours over time.

**ANSWER:** KYTC is requesting a flat fee to cover services from each consultant for individual technicians or inspectors. This was negotiated for the previous contracts. You may assume a 40 hour work week with an average of 10 hours over time for your estimate. Be aware the hours may fluctuate depending on the assignment of the technician.

**QUESTION NO. 2:** If a firm provided QA/QC to firms is the Rent-A-Tech a conflict of interest for that firm?

**ANSWER:** If a consultant firm supplies QC technicians for a contractor, it will be considered a conflict of interest if the consultant also supplies inspection services for the Department.

Consultant inspection services may be supplied to a contractor when the Department is not utilizing Consultant inspection services from that firm in the assigned Region. A firm under contract with KYTC for Consultant inspection services should not engage in providing QC inspection services to a contractor working on project(s) for KYTC in the firm's assigned Region.

**QUESTION NO. 3:** Why no travel time to and from resident engineers office?

**ANSWER:** The clock starts when the employee reports to the office where he/she is assigned. We are paying for the services of the inspector. Driving to the office is not considered part of that service.

**QUESTION NO. 4:** How much travel should one include for each district?

**ANSWER:** If travel is required it will be at the discretion of the Resident Engineer and payed at the all inclusive rate for that level of inspector. The Cabinet makes no guarantees on the amount of travel required in each district. The proposed all inclusive hourly charge should include salary, overtime, overhead, management fees and any direct costs to cover whatever is needed.

**QUESTION NO. 5:** Night time work, are we guarantee hours of work?

**ANSWER: No**

**QUESTION NO. 6: Daytime work do we have a set time guarantee?**

**ANSWER: No**

**Question: The RFP states on page 6 that, Section 2 shall contain "A summary, not to exceed ten (10) pages.....complete the project." Can you please clarify if 10-pages means "10 double-sided pages" or "10 single-sided pages"?**

**Answer: The intent of the RFP is that the Summary should not exceed ten (10) single-sided pages. The Consultant's Proposal will not be penalized if the Summary slightly exceeds ten (10) single-sided pages in order to complete a particular section of the Summary.**
